Justification for locating the project in forest area

The Training Institute is already established and running for last 23 years on the above mentioned land. The Ministry of Rural Development, Government of India has recognized our Institute as 'A' grade Institute for the entire Ramanagara Dist. and awarded a financial grant of Rs. 100 Lakhs to construct additional building / infrastructure to our institute. Accordingly, we have started construction of new building /project during May 2012, but the work has been stopped by Forest Department claiming that the land where construction being done is a forest land, where no new construction is to be carried out without requisite permission/land diversion from the Forest Dept. and doing such things is a violation of Forest Conservation Act.

The said land on which institute is established was sanctioned/allotted to us in the year 1990 (for a period of 30 years) for an extent of 3 acres by the then DC of Bangalore Rural Dist. vide his order dt.13.11.1990, and confirmed by Tahasildar vide his order dt.07.12.1990, in the name of Canara Bank Platinum Jubilee Rural Development Trust (CBPJRD). We had paid a valuable consideration of Rs.38216.60 to the Treasury 25.09.1990.(which includes cost of land and conversion charges).


The institute has already made investments by constructing eco-friendly building structure with 2 classrooms, 1 multipurpose hall, kitchen, rooms, hostel facilities and toilet blocks for boys and girls, etc. We are in the possession of this land for more than 23 years and are successfully & continuously imparting skill trainings. The institute wants to regularize the land in the form of grant/ lease by forest dept.

The Institute is running under Ministry of Rural Development, Govt. of India's R-SETI scheme. It provides free training including free boarding and lodging to unemployed youths of Ramanagara District especially from BPL families. Since 1990, Institute has trained 24167 unemployed youths/people of Ramanagara District and from other neighboring districts also.

Proposed expansion plan is to create more facilities like hostels, class rooms etc. for training these poor people.

Govt. of Karnataka, through its Principal Secretary, RD & PR Dept. is also following for early regularization of the land and also completion of construction at the earliest.

In view of the above, we are placing this proposal to Forest Dept with a request to regularize/grant the 0.97 Ha land out of 3 acres land to us so that we can continue with running of training institute and additional construction work to meet the noble objective of the Bank/Institute as well as the Central/State Governments to create self employment opportunities to the Rural unemployed youths particularly of 4 Taluks of Ramanagara Dist. and thus help solve the unemployment problem of the country.

Area Statement for Forest Area required for the project

As already stated above, Bangalore Rural Dist. DC vide his order LND 2 SR: 88-89 dt.13.11.1990, has allotted 3 acres of waste land at Sy.no.32 of Vajarahalli village for a period of 30 years to us. However, 0.97 Ha land out of 3 acre land is now required by us for the purpose of creating additional infrastructure as per Ministry Of Rural Development, Govt. of India guidelines. At present the land is utilized by us constructing 2 class rooms, 1 multipurpose hall, kitchen, rooms, hostel facilities and toilet blocks for boys and girls, etc. Further additional construction at a cost of Rs.1.50 crores, major part is being funded by Min. of Rural Devt. (MORD), GOI and balance by CBCRD Trust, will be carried out as per Govt. guidelines

Short narrative of the proposal and project/scheme for which the forest land is required:

The Canara Bank Centenary Rural Development Trust (CBCRDT) (Formerly known as Canara Bank Platinum Jubilee Rural Development Trust)(CBPJRTD) a Corporate Social Responsibility (CSR) initiative of Canara Bank has established a training centre in 0.97 Ha of land at Sy. No. 32 of Vajarahalli Village, Bidadi Hobli, Ramanagar Taluk .


The CBPJRTD has established Training Institute in the name of **A.D.Pai Institute** for Rural Development Trust (a unit of CBPJRTD, now CBCRDT) in the said 0.97 Ha of land specifically for the purpose of establishing a Self-employment Training Institute.

The 3 acres of land was sanctioned/allotted to us in the year 1990 (for a period of 30 years) by the then DC of Bangalore Rural Dist. vide his order dt. 13.11.1990. And confirmed by Tahasildar vide his order dt.07.12.1990, in the name of Canara Bank Platinum Jubilee Rural Development Trust (CBPJRTD). We had paid a valuable consideration of Rs.38216.60 to the Treasury 25.09.1990.(which includes cost of land and conversion charges).

Since then we are enjoying peaceful possession of said 3 acres of land and continuously imparting training to the Rural unemployed youths to take up self-employment projects, help them to set up their own establishments and undertakings and contributing to solve unemployment problems to a great extent by constructing eco-friendly building structure with 2 classrooms, 1 multipurpose hall, kitchen, rooms & hostel facilities and toilet blocks for boys and girls etc.
