मुझे आपका ध्यान उपर्युक्त प्रस्ताव की ओर दिलाने का निर्देश हुआ है,जिसमें वन (संरक्षण) अधिनियम, 1980 की धारा-2 के अनुसार गैर वानिकी उद्देश्य के लिए 0.0076 हेक्टेयर वन भूमि की मांग की गई है |

- 2. प्रस्ताव से सम्बंधित निम्नलिखित जानकारी भेजने का कष्ट करे:
 - i. Name of User Agency is not uploaded correctly.
 - ii. Authorization letter is not uploaded correctly. The person making application and authorized to sign all documents should be same.
- iii. Under column village wise break-up and component wise break-up, non-forest land is uploaded as 1.57 ha, instead of 0.47 ha.
- iv. Temporary employment generated is shown as 0. This needs to be updated rationally.
- v. NOC from NHAI is given but it is expired on 15.07.2022.
- vi. NOC from Pollution Control Board is not given.
- vii. Penal CA and Penal NPV have been mentioned in CA scheme. This needs to be removed as there is no such provision as per Handbook of Forest (Conservation) Act, 1980 and Forest Conservation Rules, 2003 (Guidelines and Clarifications), 2019, MoEF&CC.
- viii. SOI toposheet of CA site is uploaded without SOI toposheet number.
- ix. Separate NPV calculation needs to be submitted.
- x. DGPS map of Project site needs to be revised as latitude/longitudes are not falling of uploaded KML file.
