Coal Pulz Private Limited in whose favour the coal block was auctioned/re-allotted by the Ministry of Coal, in accordance with para 5.4 of the Guidelines given under the Handbook of the Forest (Conservation) Act, 1980.

- 2. With reference to above and after examination of the proposal the State Govt. is requested to submit the following documents/information :
- (i) The State Govt. has not submitted the requisite information wrt to Ministry's letter of even no. dated 24.01.2014 vide which the below mentioned were sought:
 - a. How much CA, penal CA and NPV was due for entire 128.97 ha. and how much have realized/deposited in the account of Ad-hoc CAMPA? Details may be furnished in the format prescribed by the OSD, Ad-hoc CAMPA.
 - b. whether non-forest land has been mutated and transferred in favour of the State Forest Department.
 - c. Justification for delay in compliance report in respect of 89.95 ha. of forest land may be submitted.

In this regard, the State Govt. is requested to submit the above information.

- (ii) It was informed by the Ministry of Coal vide letter 05.09.2023 that the affidavit required to be submitted for transfer of Forest Clearance in accordance with the guidelines dated 28.03.2019 issued by MoEF&CC has also been submitted by M/s. Coal Pulz Private Limited. But the copy of the same is not enclosed in the letter. In this regard the State Govt. is requested to submit the copy of the affidavit.
- (iii) The State Govt. is requested to submit the complete compliance of the Ministry's approval letter (for Stage II) dated 10.04.2006.
- (iv) The original copy of the notification of CA which was done as RF/PF under Section 4 and Section 29 of the Indian Forest Act, 1927 or other local Act, is required from the State Govt.
- (v) The State Govt. is requested to submit the KML files of the forest area (i.e 128.97 ha) for which in-principle approval was granted vide letter dt 09.06.2004 clearly demarking the area of 39.02 ha for which the Stage-II approval was granted out of 128.97 ha.
- (vi) The State Govt. is requested to submit the KML files of the CA area along with the status of plantation and its survival rate.
- (vii) The State Govt. is requested to submit the status of compliance wrt the Safety Zone in accordance with Chapter 7, para 7.9 of this Ministry's Comprehensive Guidelines issued in 2019. The State Govt. is also requested to submit the KML files of the safety zone and 1.5 times plantation area.

In view of the above, the Government of Arunachal Pradesh is requested to submit the above information/documents to this Ministry for further consideration of the instant proposal for transfer.



After careful examination of the proposal of the State Government and on the basis of the recommendations of the Committee mentioned above, the Central Government hereby agrees in-principle for diversion of 128.97 ha. of forest land for Open Cast Coal Mining Project in Namchik-Namphuk Coal Fields in Changlang district of Arunachal Pradesh in favour of Arunachal Pradesh Mineral Development and Trading Corporation Limited subject to fulfilment of the following conditions:-

The State Government shall charge the Net Present Value of the forest area diverted under this proposal from the User Agency as per the Orders of the Hon'ble Supreme Coun of India dated 30-10-2002 and 01-08-2003 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by this Ministry vide letters No. 5-1/1998-FC (Pt. Kindly refer to the State Government's letter No. FOR 14-7/CONS/2002/169-72 dated 30.04.2003 on the subject mentioned above seeking prior approval of the Central Government under the Forest (Conservation) Act, 1980. After careful consideration of the proposal by the Forest Advisory Committee constituted under Section-3 of the said Act, in-principle approval for diversion of 128.97 ha of forest land for the said Mining Lease was granted vide this Ministry's letter of even number dated 09.06.2004 subject to fulfilment of certain conditions. Further, vide letter dated 30.06.2004, considering a request made by the State Government, it was agreed by the Central Government to allow phase-wise mining as the forest land shall be broken in phases, and to divert only 39.02 ha (out of a total of 128.97 ha agreed in-principle for diversion) in the first phase of five years. The State Government has furnished compliance report accordingly and has requested the Central Government for granting final approval.

Till such time an appropriate Head of Account is communicated in this regard, such funds shall be kept in the form of Fixed Deposits in the name of the concerned DFO or the Nodal Officer in any Nationalised Bank as per the guidelines issued by the Ministry of Environment and Forests dated 22.03.2004.
