**Madam/ Sir,**

May please refer to above captioned subject matter and Ministry's letter of even no. dated 14.07.2020 and reminder letter of even no. dated 08.09.2020; wherein, Regional Office, MoEF&CC, Bhopal had been requested to submit the Site Inspection Report regarding above referred proposal along with the long pending information in respect of "Sardar Sarovar Project" sought by Ministry from the State Government vide letter no. 8-99/2010-FC dated 27.07.2017 and DO letter of Secretary (EF&CC) dated 25.06.2020. Copies of all referred letters are enclosed.

2. A Site Inspection Report from the Integrated Regional Office, Bhopal vide letter no. 6-MPA010/2020-BHO dated 30.09.2020 has been submitted; wherein, the instant proposal is recommended subject to fulfillment of following observations:

- i. The proper KML file of proposed diversion of 505.50 ha shall be uploaded on e.portal.
- ii. The 6 Power Transmission Line (5 from PGCIL & 1 Sterlite) is passing from the project area. The State Govt. needs to submit the plan addressing the issue of shifting of transmission line.

3. 'No Objection Certificate' from Power Transmission Line Companies referred also needs submission in relation to this forest land diversion proposal. It is once again reiterated that the long pending information regarding "Sardar Sarovar Project" sought by Ministry may also be submitted with the reply.

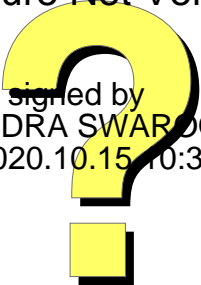
