Odisha Mining Corporation Ltd.
 - (ii) Additional mitigation measures that have become necessary in view of new facts on the ground and considering the proposed extension of approval and
 - (iii) Comprehensive status of reclamation of mined-over/ abandoned portions of the forest area as per approved mining plan.
