Kindly refer to letter no. F-5-42/2023/10-2 dated 02.08.2024 from the Government of Chhattisgarh regarding the subject mentioned above, forwarding the compliance report concerning the conditions stipulated in the 'In-principle' approval dated 09.10.2023, and requesting final approval of the proposal.

Upon examination of the compliance report by the Regional Office, MoEF&CC, the following observations were noted:

- i. The State Government has not submitted the compliance report through Parivesh 1.0 (online), as required by the prevailing rules.
- ii. The OFC proposal involves the diversion of 6.713 Ha. of forest land, which exceeds 1 Ha. Therefore, clarification on the status of the existing road Right of Way (RoW) is required.
- iii. The Compensatory Afforestation (CA) scheme has not been submitted.

In view of the above, the State Government is requested to furnish the required information/documents as indicated above to this office for further necessary action.
