In this regard, it is to inform that the Government of Madhya Pradesh vide their letter No. F-3/53/2018/10-11/15/4119 dated 09.12.2021 forwarded the instant proposal to the Ministry where in the Part-II of the online application form, the density of proposed forest land is reported as 0.4. Further the IRO, Bhopal vide letter no. 6-MPA001/2022-BHO/069 dated 18.04.2022 submitted its Site Inspection Report wherein the density of proposed forest land is reported as 0.4 Now the Government of Madhya Pradesh vide their letter dated 23.12.2022 has mentioned as under:

2. Accordingly, it is requested to furnish the inputs/clarification to this Ministry for further consideration of the proposal for grant of Stage-II approval.
