I am directed to refer to the Government of Himachal Pradesh proposal No. FP/HP/MIN/34194/2018 on the above-mentioned subject seeking prior approval of Central Government under Section 2 (1) (ii) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. In this regard it is to inform that the matter was discussed in the Advisory Committee (AC) in its meeting held on 27.10.2025. The detailed minutes of the said AC meeting are uploaded at *parivesh.nic.in*. The Committee after detailed discussion and deliberation with the DDGF (Central), RO, Chandigarh and officials from the Government of Himachal Pradesh and after going through the facts of the proposal, the Committee decided to 'defer' the proposal with the following observations (interlia).

ii. It is been reported that the user agency has submitted a proposal FP/HP/IND/35171/2018 for diversion of 0.0934 ha of Protected Forest (0.062 ha) and Gair Mumkin Machine (0.0314 ha) for renewal of already established Stone Crusher. The instant proposal pertains to diversion for mining lease, safety zone, approach road and for stacking of raw material. Therefore, the State Government is requested to clarify if these two proposals are interlinked and, if so, reason for applying separately may be submitted.
