The work in this area is stopped and POR had filed against Project Authority on dated 30.06.2020 for Survey No.63 & 28 of Mauza Salai Rithi of Katol Range vide POR No. 04892/122280/2023 and again POR had filed against Project Authority on dated 04.05.2023 for Survey No. 21 of Mauja Bhajipani of Katol Range vide POR No. 04894/124578/2021. ANNEXURE - 1

VIOLATION REPORT

The Maharashtra State Electricity Transmission Company Limited (MSETCL), Government of Maharashtra Undertaking, has decided to take up construction of 220 kV Kalmeshwar-Warud Transmission Line for augmentation of the electricity grid network towards increasing demand of power in the Warud region.

The total length of the project stretch selected for construction of the line is 67.253 kms. Part of this line is passing through forest area of (1) Gut No. 74 of Village Pardi (Gotmare) 0.4375 Ha, (2) Gut No. 34 of Village Bordoh 0.0980 Ha, 3) Gut No. 48 of Village Pathar 0.1295 Ha, (4) Gut No. 6,7,16,21 of Village Bhajipani 1.1130 Ha, (5) Gut No. 126,116,89,70 of Village Dongargaon 1.9565 Ha, (6) Gut No. 63,28 Village of Salai Rithi 1.3195 Ha, (7) Gut No. 68,63 of Village Karla 0.4865 Ha from Katol Range and (8) Gut 88, 64 Village Tarabordi 0.4375 Ha from Kondhali Range of Nagpur Forest Division. The proposed line requires diversion of Total 6.0760 Ha in Nagpur Forest Division. Therefore the construction of this line requires forest clearance from Ministry of Environment Forest and Climate change (GOI).

The diversion of forest area has been limited to the minimum that satisfies the standards of Central Board of Irrigation and Power. As the project line is passing through the middle of the forest area, avoiding forest area is not possible. Alternatives has been examined and found that no better option is available.

Part of construction of this line is done for erection of towers and stringing at places on forest land and thereby violation of Forest Act from year 2014 to 2018.


The work in this reach is stopped and proposal for approval under Forest (Conservation) Act is submitted by the Project Authority.

As the proposal is for construction of transmission line and there is no suitable alternative for the same and project authority has submitted the proposal for obtaining approval from Government of India. Hence, it is required to process the proposal for diversion of Forest Land (Zudpi Jungle) under the provisions of Section 2 of Forest Conservation Act, 1980.

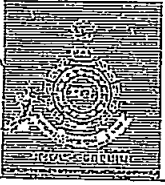



- 1) The forest area where violation happened was originally recorded as Zudpi Jungle land which is proposed reserved forest (notified u/s 4 of IFA 1927).
- 2) The Project Authority has executed construction of 3 foundation & stringing at places on forest land on the survey no. 28, 63 of Salai Rithi & survey no. 21 of Bhajipani of Katol Taluka.
- 3) As the proposal is for construction of Transmission Line connecting Kalmeshwar Substation to 220 KV Warud Substation, there is no suitable alternative for the same and project authority has submitted the proposal for obtaining approval from Government of India.
- 4) The violation may be condoned by charging NPV at 5 times of the NPV plus 12% simple interest till the deposit is made over the area of 6.0760 ha.
- 5) The following conditions may be imposed upon the Project authority.
 - a. Minimum distance between electrical conductor 3.9 meters, it exceeds the wingspan of the largest birds found in the area.
 - b. To avoid accidental collision of birds with power lines, suitable mitigation measures like bird diverts should be planned at suitable locations.

With reference to letter under ref. 1 above the proposal of the subject matter was submitted to the State Government for decision of the State Wildlife Board. In the 22nd meeting of the State Wildlife Board dated 16/10/2023 the subject proposal was presented before the Board for decision. The Board recommended that the proposal presented in the said meeting be forwarded to the National Wildlife Board on the terms laid down by the Chief Wildlife Warden, Maharashtra State.

As per the decision of the 22nd State Wildlife Board of the State Wildlife Board, in order to fulfill the conditions laid down by the Board, the project authority was informed to fulfill the following conditions under reference letter 3.

1. The cost of mitigation measures suggested by the Wildlife Institute of India, Dehradun should be borne by the project authority.
2. As per Indian Electricity Rules, about 220 kV power lines must be at least 7 meters above the ground.
3. A vertical distance of 3.9 meters should be maintained between two conductors/conduits to prevent electric shock to birds. This can reduce the risk of electrocution of large winged birds.
4. To avoid accidental collision of birds with power lines, suitable mitigation measures like bird diverts should be planned at suitable locations as suggested by CEA/MOEF&CC.
5. Minimum distance between electrical conduits 3.9 meters, it exceeds the wingspan of the largest birds found in the area.

6. In addition to the above proposed mitigation measures, mitigation measures prescribed by the Forest Department and other scientific bodies and conservation and protection of biodiversity will be implemented by the project authority.
7. Increasing the tower height of the existing mesh structure within the technical limitations based on the flight behavior of the birds.
8. Other specific measures as suggested by the Forest Department.

Considering the public utility of the project, the proposed project will be recommended subject to the following additional conditions

- i. 2% of the project cost should be made available as conservation and protection fund for conservation and protection of wildlife.
- ii. The mitigation plan suggested by the Wildlife Institute of India, Dehradun should be implemented by the project authority at its own cost.
- iii. The project staff engaged in the work of the project shall comply with the provisions of all existing laws, particularly the Environment Protection Act, 1986, the Wildlife (Protection) Act, 1972, the Forest (Protection) Act, 1980 and the rules made there under, shall take precautionary measures for the conservation and protection of flora and fauna in the project area.
- iv. The proposed project requires cutting of 386 trees. The cost of planting trees should be borne by the project system
- v. Barricading should be provided at the work site of tower construction to avoid any human or wildlife accident.
- vi. The project authority should ensure that no debris is dumped on any water bodies and forest areas.
- vii. Care should be taken not to lay and pass transmission lines to minimize impact on corridors.
- viii. All other mandatory permissions from various statutory authorities should be obtained before commencing work.
- ix. It will be ensured that there is no damage or disturbance to wildlife and their habitat.
- x. Due to the violation of the Wildlife (Protection) Act, 1972 by the project authority, the 1% amount of estimated sum of Rs. 5.00 crores Rs. 5.00 lakhs to be paid as penalty.

In accordance with the above conditions, the project authority as per condition-I, 2% i.e. Rs. 0. 10 crore and as per condition No. X the amount of penalty is Rs. 0. 05 crores totaling Rs. 0. 15 Crores has been paid through (RTGS) dated 30/10/2023 to the Tiger Conservation Foundation of the Director of Forest Conservation and Area, Pench Tiger Reserve, Nagpur for conservation and protection of wildlife sanctuaries in Maharashtra State

Also condition no. in respect of 1 to 8 and ii to ix, a written undertaking has been submitted on stamp paper. A report in this regard has been submitted to this office by the project authority under reference letter-4. (Copy attached).

Accordingly it is requested to submit the said proposal along with Part V to the Central Government for decision of the National Wildlife Board.
