Sub: Proposal for non-forestry use of 159.895 ha of forest land for construction of Chheligada Medium Irrigation project in R. Udayagiri Block of Gajapati district. – Stage-I compliance regarding.

Sir,

I am directed to refer to the State Government of Odisha's letter no. no. 20106/9F (Irrig.) -207/04 dated 29.09.2022, on the above subject forwarding reply in response to Ministry's letter dated 16.09.2022. After examination of reply submitted by the State Government, using DSS tools (report enclosed), revealed the following:

- 1. Complete and exact KML of the entire project area were not submitted. The same needs to be submitted depicting the area vis-à-vis land use proposed.
- 2. State Government has mentioned that as per DGPS survey the net project area has been reduced to 139.319 ha, against the area of 159.895 ha estimated using physical surveys. Contrary to the submission made in respect of DGPS surveys, ML files have been submitted corresponding to 158.815 ha i.e. area actually applied for diversion. Moreover, as per area estimates generated from KML files submitted by the State, difference in the area was observed only in respect of a site namely Suguba i.e. as per DGPS survey, the estimated area is 13.584 ha while corresponding KML file depicted the area as 33.971 ha. Therefore submissions made by the State that change in the area is due to physical and DGPS survey does not seem to be convincing. Therefore, a valid cogent justification for reduction in the area needs to be furnished by the State along with the following:
 - i. Details of changes (+/-ve) in the total project area may be furnished by the State.
 - ii. Correct KML files of the area deduced from the DGPS surveys may be furnished by the State.
- 3. Area is located at a distance of 8.75 km from the Lakhari Valley Wildlife Sanctuary. Therefore, State Government may submit their considered opinion on the applicability of clearance from the Standing Committee of NBWL.
- 4. Unambiguous information requested under point no (viii) of the Ministry's letter dated 16.09.2022 has not been furnished. State Government needs to confirm if the entire forest land involved in the project, based on its legal status as on 25.10.1980, is applied under the extant proposal or otherwise.
- 5. National Authority CAMPA vide their OM no. 1-26/2017-CAMPA (Pt.I) dated 12.09.2022 (copy enclosed) requested to furnish the particulars of the remittances. The same may be provided.

In view of above, the State Government is requested to submit information/documents/comments, as indicated above, to this Ministry for further necessary action in the matter.

2. There is difference of approx. **20 ha** in the software-calculated area and DGPS survey area of **Suguba village**.

791886/2032/FC posed project is located at an approx. distance of 8.75 km from Lakhari Valley wildlife sanctuary.

- 4. Proposed area for diversion falls in **Not-in High Conservation Value Zone** based on Decision Rule1 and Decision Rule2.
- Out of total proposed area, 6 ha is classified as very dense forest, 28 ha as moderately dense forest, 43 ha as open forest, 2 ha as scrub and 80 ha of land as Non Forest (land without tree cover) in terms of forest classes (as per the ISFR 2021) based on the interpretation of satellite data period 2019-2020.
- 6. Component wise (Landuse) KML file of proposed area is not available. Further, KML file of total project area is also not available.
- 7. Observations based on high resolution Google Earth images: encroachment of agriculture land and road is visible in the proposed forest area.








