**Sub: Request of user agency i.e. NMDC Limited for Amendment in conditions of the Stage-I FC transferred to NMDC Limited from previous user agency M/s Rohne Coal Company Private Limited. –reg.**

Sir,

I am directed to refer to State Government's letter no. 3/Van Bhumi-100/2009-1406 V.P. dated 20.05.2022 on the above subject forwarding the request of user agency i.e. M/s. NMDC Limited to amend in the conditions of Stage-I approval dated 23.01.2013 i.e. to raise and maintain Compensate Afforestation over degraded forest land twice in extent of diverted area in place of non-forest land specified in the Stage-I approval. In this connection, it is to inform that the matter was considered by the Forest Advisory Committee in its meeting held on 21.09.2022. Based on the recommendation of the FAC and approval of the same by the competent authority of the Ministry, the Central Government hereby clarifies that the CA should be raised as per the conditions stipulated in the Stage-I approval and compliance of all other conditions will be ensured by the user agency.

In view of above, I am directed to request the State Government to direct the user agency to ensure compliance of Stage-I approval as per decision taken by the Central Government and a report on the same may be submitted to the Ministry for further necessary action in the matter.

**Sub: Modification in condition of Stage-I approval dated 20.09.2010 of change in CA land from Non-forest land to degraded forest land - Proposal for non-forestry use of 150.49 ha of forest land in favour of M/s NTPC Limited (Originally approval in favour of M/s Tenughat Emta Coal Mines Limited) for Badam Coal Mining Project in Hazaribagh District in the State of Jharkhand- reg.**

Sir,

I am directed to refer to the State Government of Jharkhand's letter no. 3/Van Bhuni-44/2008-2545 V.P. dated 01.09.2022 on the above subject seeking prior approval of the Central Government under the Forest (Conservation) Act, 1980 and to say that the proposal was examined by the Forest Advisory Committee in its meeting held on 21.09.2022. The Minutes of the FAC meeting may be accessed at [www.parivesh.nic.in](http://www.parivesh.nic.in). The Committee, after detailed discussion and deliberation on the proposal, took a serious note of the tendency of the user agency to avert the conditions on which forest land was transferred to the user agency and recommended raising of CA as stipulated in the Stage-I approval as the user agency was aware of the conditions stipulated in the Stage-I approval, and had also given an undertaking to abide by these conditions while seeking transfer of approval.

Based on the recommendation of the FAC and approval of the same by the competent authority of the Ministry, the Central Government conveys the following:

- i. CA should be raised as per the conditions stipulated in the Stage-I approval dated 20.09.2010 and compliance of all other conditions will be ensured by the user agency.
- ii. To check the tendencies among various user agencies to avoid compliance of the conditions prescribed in Stage I FC approval after having given an undertaking that they shall abide by such conditions in other similarly placed cases, the action proposed in the extant case, as indicated in the above para, shall be *mutatis mutandis* applicable.
