I am directed to refer to the Additional Principal Chief Conservator of Forests (Land Management) & Nodal Officer, FCA, Govt. of Madhya Pradesh's letter No. F-5/859/2019/10-11/3620 dated 02.11.2021 on the above subject forwarding a report on the compliance of conditions stipulated in the Stage-I approval dated 06.09.2021 and to say that after careful examination of the said report, following shortcomings have been observed: -

- i. The user agency has not submitted the undertaking of the condition No. A(i), B(i), B(ii) of the Stage –I approval.
- ii. The user agency has not submitted the detailed proposal as per condition no. A(ii) of the Stage –I approval.
- iii. The details regarding cost of felling of trees deposited by the User Agency with the State Forest Department shall be submitted.
- iv. The records of all consultations and meetings of the Forest Rights Committees(s) i.e. Gram Sabha, Sub-Division Level Forest Rights Committee and Divisional Level Forest Rights Committee shall be submitted.
- v. The State Government shall provide the details of KML files of the area under diversion and the accepted area for raising compensatory afforestation uploaded on the E-Green Watch portal of FSI.

In view of the above, the State Government is requested to furnish the above mentioned information to this Ministry for further consideration of the proposal for according Final/Stage-II approval.
