Sir,

I am directed to refer to Government of Karnataka's letter No. FEE 16 FFM 2021 dated 30.12.2021 on the above mentioned subject forwarding the additional information in response to this Ministry's letter dt 06.08.2021. The State Govt. vide this letter has informed that Chief Conservator of Forests, Ballari Circle has inspected the proposed site on 25.11.2021 and has reported the following violations committed by the User Agency:

- i. The user Agency has already laid pipeline about 400 mtrs (i.e. 0.08 ha) length in the proposed screening Plant-II AREA.
- ii. The User Agency has already established washing plant about 0.1 ha in the proposed Screening Plant-II area.
- iii. The User Agency has already established Conveyor belt about 363 mtrs length in the proposed screening plant-II area and about 376 mtrs length in tailing dam-I area.
- iv. The User Agency has already established check dam, silt settling tank and rainwater harvesting pit in the proposed tailing dam-II area. Further, these are related to R&R activities implemented by the User Agency with respect to ML No. 2396.
