Sir,

I am directed to refer to the Addl. PCCF& Nodal Officer, Government of Arunachal Pradesh's letter No. FOR. 9-313/Cons/2010/3308-11 dated 3rd July, 2024 and letter no. FOR.313/Cons/2010/3862-65 dated 11.09.2024 forwarding compliance of in-principle approval dated 27.10.2015 and additional information sought by the Ministry in its letter dated 20.08.2024, respectively and to say that compliance submitted by the State Government, along with changed CA site, was considered by the Advisory Committee in its meeting held on 14.10.2024. The detailed minutes of the said AC meeting are uploaded at *parivesh.nic.in.*

Based on the recommendation of the Advisory Committee and approval of the same by the competent authority of the MoEF&CC, New Delhi, the Central Government hereby conveys its approval for change in the site for raising compensatory afforestation as proposed by the State Government over an area of 100 ha of degraded forest land in Jorji-Takke-Pujo RF.

The Committee, after further examination of the compliance report of inprinciple approval, desired that following information may be submitted by the State Government:

- i. The State Government shall submit detailed justification supported with valid and cogent reasons, along with a request for condonation of delay for submission of compliance report within the stipulated period.
- ii. Against the total cost of ₹3,76,03,300/- estimated for the implementation of the CA scheme, an amount of ₹3,65,05,500/- has been deposited by the user agency. The differential amount of ₹10,97,800/- also needs to be deposited by the user agency into the account of CAMPA.
