Please refer to Government of Rajasthan letter No. P.1(133) Van/2022 dated 17th November, 2025 addressed to Sub-Office, MoEF&CC, Jaipur on the above mentioned subject. In this context, the compliance report of Stage-1 approval submitted by the State Government has been examined by the Ministry. The observation on the compliance report are as follows:-

(i) In compliance of Condition No. (ii), the State Government has not submitted any information/comments regarding action taken as per Para 1.16(ii) of the comprehensive guidelines dated 29.12.2023. The State Government shall submit the details in this regard in compliance of condition No. (ii) of Stage-1 approval.

(ii) In compliance of condition No. (iii), the State Government has not submitted information regarding inquiry into the matter and in case any permission has been accorded by an authority in the State for the use of forest land for non-forestry purpose in the instant case, then action u/s 3A/3B shall be initiated by the State as applicable. The State Government shall submit the details in this regard in compliance of condition No. (iii) of Stage-1 approval.

(iii) The State Government/User Agency has not submitted an undertaking regarding compliance of condition No. (iv) regarding Penal CA. The State Government shall submit an undertaking in compliance of condition No. (iv) of Stage-1 approval.

In view of the above, it is requested to submit the above information/documents at the earliest for further processing the proposal.
