I am directed to refer to the Government of Arunachal Pradesh letter No.FOR.313Cons/2010/5886-92 dated 17.10.2023 and additional information submitted vide letter No. FOR.313/Cons/2010/638-43 dated 09.01.2024 with a request to change in the name of the user agency from M/s Siyota Hydro Power Ltd (original User Agency) to North Eastern Electric Power Corporation Limited (NEEPCO Ltd.) (a Govt. of India Enterprise) in respect of diversion of 52.8 ha of forest land (surface forest land- 47.7 ha, river-bed-2.3 ha & underground area-2.8 ha) in favour North Eastern Electric Power Corporation Ltd (NEEPCO Ltd). for construction of Tato-I HEP (186 MW) in Shi- Yomi District earlier in West Sian District of Arunachal Pradesh.

After careful examination of the proposal in accordance with para 5.1 of the comprehensive Guidelines issued under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for change in the name of user agency, the Central Government hereby conveys its approval for change in the name of the user agency from M/s Siyota Hydro Power Ltd (original User Agency) to North Eastern Electric Power Corporation Limited (NEEPCO Ltd.) (a Govt. of India Enterprise) in respect of diversion of 52.8 ha of forest land (surface forest land- 47.7 ha, river-bed-2.3 ha & underground area-2.8 ha) in favour North Eastern Electric Power Corporation Ltd (NEEPCO Ltd). for construction of Tato-I HEP (186 MW) in Shi- Yomi District earlier in West Sian District of Arunachal Pradesh by NEEPCO Ltd., subject to the conditions stipulated in the Stage-I approval dated 27.10.2015 and also fulfillment of the following additional conditions:
 - i. The State govt. shall ensure that the transfer fee of₹10,00,000 (Rupees ten lakh) is deposited into CAMPA account of the concerned State Government.

- ii. The new user agency shall pay the NPV as per the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC dated 06.01.2022 read with 22.03.2022 through online portal of CAMPA account of the State Concerned
- iii. The new user agency shall also pay the additional NPV, if so determined by the Hon'ble Supreme Court of India;
- iv. The new user agency shall abide by all the conditions on which the forest land was leased/diverted in favour of the original user agency;
- v. The new user agency shall abide by any other condition that may be stipulated by the Central Government/Regional Office/State Government in future in the interest of conservation, protection, and development of forests & wildlife.
- vi. The State Govt. and the user agency shall comply with the provisions of all Acts, Rules, Regulations, Guidelines & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.
