विषय: Diversion of 0.8738 ha. of forest land in favour of Suket Hydro 75/11 Tarna Hill Mandi, HP for the construction of Suket Small Hydro Project on Suketi Khad (1.00 MW), within the jurisdiction of Mandi Forest Division, Distt. Mandi, Himachal Pradesh. (Online Proposal No. FP/HP/HYD/40895/2019).

संदर्भ: Online Proposal No. FP/HP/HYD/40895/2019 uploaded by State Government on dated 27.12.2022.

महोदय,

उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत प्रतिउत्तर का ध्यानापूर्वक अवलोकन करने के पश्चात प्रतिउत्तर में अभी भी निम्नलिखित कमियां पाई गई हैं:—

1. The reply submitted by State Government in respect to observation no. 1 is not found satisfactory. Therefore, clarification/necessary documents on below mentioned points may be provided:
 - a. It has been submitted by State Government that road component is proposed in *Khasra* number 8/3/18 whose area as per revenue records is 0.1286 ha, however area proposed for road component upto power house is 0.1603 ha.
 - b. The detail of *Khasra* number and purpose wise components proposed along with area and dimensions of each proposed component in tabulated form.
 - c. As per proposal, road component is proposed upto Power house, however, it has been revealed from Layout Plan and KML file that this proposed road is extended beyond power house upto water channel.
 - d. In *Tatima*, a component is marked having *Khasra* number 8/3/8, 8/3/9 and 8/3/10 which is not shown in Layout Plan.
2. In revised Layout Plan, Dumping Site no. V and VI are not marked.
3. As desired, all records of consultations and meeting with concerned FRC(s) and Gram Sabha(s) are not found uploaded.
4. NoC of Fisheries Department is not found uploaded.
5. It has been observed from uploaded CA scheme that 1748 trees are to be planted in proposed 01 ha area. However, as per FCA Guidelines 1000 plants are to be planted in 01 ha. Therefore, same may be reviewed and additional 0.748 ha CA area for plantation of remaining plants may be provided/uploaded.
6. The reply submitted by State Government in respect to observation no. 8 regarding Beas Basin Study is not clear and satisfactory. Therefore, same may be reviewed and satisfactory compliance of observation may be submitted.
7. The Geo-referenced uploaded in Para-I, Para-C is in blurred form. Therefore, legible copy of the same with marking of all components may be submitted.
8. In reply to observation no. 10, it has been submitted that revised Layout Plan has been uploaded. However, it has been observed that still there is mismatch in dimension of proposed transmission

Line and Road Component. Therefore clarification/necessary documents on following points may be submitted.

- The dimensions of proposed Transmission Line in transmission detail document uploaded in portal is mentioned as 163.5*0.6 meter, however, in revised Layout Plan, dimension of proposed Transmission Line is taken as 13.2*15 meter. There is mismatch in dimensions, and proposed RoW as 15 meter is not as per FCA Guidelines.
- The dimensions of proposed road upto Power House in detail of forest land for power house uploaded in portal is mentioned as 264.13*30 meter, however in revised Layout Plan dimensions are mentioned as 400.75*4 meter.
