**Name of the proposal: Re-Diversion of 0.467 ha of Forest Land for construction of Link Road between two defense complexes (ARDE Pune, DRDO)**

**G. Background on the proposal:** There exists an inspection path maintained by the Forest department, which is being proposed for further development as a pakka road. Previously, Government of India, Ministry of Environment, Forest and Climate Change, New Delhi has given final approval for diversion of 55.74 ha. forest area to Automotive Research Association of India (ARAI) for laying down of test track for lab under Forest (Conservation) Act, 1980 vide letter dated 24/07/2008 in which condition no.15 i.e. "The diversion of land may be done after considering the issue of ARDE also" was laid down.

The then Conservator of Forests, Pune vide letter dated.09/02/2009 gave permission to ARAI for non-forest use of the said land in accordance with the final approval for MoEF&CC vide letter dated 24/07/2008. Later Principal Chief Conservator of Forests (Head of Forest Force) Maharashtra State revoked the said order passed by then Conservator of Forests, Pune for the reasons of non-fulfillment of condition no.15 in the final approval granted by MoEF&CC and also ordered user agency not to start any work over the said area and not to divert the said land to user agency until any further orders are passed by the State Government.

The Deputy Conservator of Forests, Pune Forest Division, Pune has taken one sided possession on 29/01/2019 of Village Kothrud Forest Survey No.102 area of 98.045 ha. out of 105.74 ha. excluding the 7.695 ha. arca under possession of ARAI. On 01/06/2018, the Government of Maharashtra informed to the Secretary, Department of Defence, New Delhi about all the facts about forest land in Survey no.102 at Kothrud, Dist. Pune. In above letter para no.7 mentioned that "permission for re-diversion cannot be accorded without prior written consent of the primary user agency".

Regarding diversion of 55.74 ha. forest area to ARAI under Forest Conservation Act, 1980, The Nodal Officer has submitted report to the Government of Maharashtra vide letter No. Nodal/RS-II/ID-11293(S)/1308, dated 04/03/2021 for necessary directions / instruction regarding diversion of land to ARAI. The Government of Maharashtra has so far not issued any diversion order for the forest land in favour of ARAI and the area proposed for diversion (0.462 ha.) is a part of the same 55.74 ha. forest area for which Stage-II Clearance was given by the MoEF&CC, Govt. of India vide letter No. 8-15/2007-FC, Dt 24.07.2008 (FP/MH/OTHERS/1037/2007)


