Sub.: Request to facilitate grant of Forest Clearance (FC) for diversion of 24.906 ha forest land located under Safety Zone of Kiriburu-Meghahatuburu Iron Ore Mines Amalgamated Lease Area (2897.499 ha), Bokaro Steel Plant of SAIL

Respected Sir,

In reference to the subject and the MoEFCC guidelines referred above, the following information regarding Kiriburu-Meghahatuburu Iron Ore Mines is submitted for your kind consideration.

The amalgamated lease of Kiriburu-Meghahatuburu Iron Ore Mines covering an area of 2897.499 ha is located in West Singhbhum District, Saranda Forest Division. The amalgamated lease has been extended and executed by the GoJ up to 27.03.2030.

Under the amalgamated lease area 2897.499 ha, Stage-II FC's obtained at different period for 644.26 ha, 55.90 ha, 1.7 ha, and 24.23 ha, totalling 726.09 ha. During the diversion of 644.26 ha, the PCCF, Jharkhand, vide letter dated 02.07.2009, informed the Secretary (F&E), GoJ that the three leases of Kiriburu-Meghahatuburu mines have been approved with a safety zone area of 24.906 ha. The said letter also states that the project proponent will cover the costs of construction, safety measures, and dense plantation, and afforestation on DFL, measuring 1.5 times the safety zone area to be undertaken by the user agency (Annexure-I).

Since 2009-10, 24.906 ha of the area has been fenced and maintained as a Safety Zone along the 7.5 m inner boundary of the amalgamated lease area. Furthermore, as per the demand of the DFO, Saranda, an amount of Rs. 22.62 lakhs was deposited by SAIL on 01.06.2010 towards the CA scheme for 1.5 times the Safety Zone area. Additionally, NPV amount of Rs. 278 crores has been paid for the entire amalgamated lease area, including the Safety Zone area.

Meanwhile, MoEFCC vide letter no. FC-11/151/2022-FC dated 07.11.2022 issued a guideline on Safety Zone, which directs the user agency to submit proposal and obtain

approval under the Forest (Conservation) Act, 1980 for diversion of forest area located in the safety zone by 30.09.2023 (Annexure-II). Further, MoEFCC vide guideline dated 04.12.2023 extended the time period for obtaining approval under FC Act, 1980 till **30.09.2024** (Annexure-III)

Therefore in compliance to MoEFCC guideline dated 07.11.2022, a proposal under the v). FC Act, 1980 was submitted on the PARIVESH 2.0 for diversion of 24.906 ha forest land located under Safety Zone within the Amalgamated Lease Area (2897.499 ha) of vide Proposal Ore Mines. Iron Kiriburu-Meghahatuburu FP/JH/MIN/QRY/443438/2023 dated 07.09.2023 (copy of Form-A attached at Annexure-IV). In this regard Project Screening Committee (PSC) meetings were held on 14.03.2024, 21.06.2024 and 26.07.2024. Further, PSC recommended the proposal on 31.07.2024. Subsequently, PCCF (Nodal), GoJ, vide letter dated 29.08.2024, forwarded the proposal to the Secretary (F, E & CC), GoJ, for obtaining Stage-I FC and further necessary action (Annexure-V).

In view of the above stated facts and considering the MoEFCC guidelines dated 07.11.2022 & 04.12.2023, it is requested that the proposal for diversion of 24.906 ha forest land located under Safety Zone within the Amalgamated Lease Area (2897.499 ha) of Kiriburu-Meghahatuburu Iron Ore Mines, be forwarded to MoEFCC at the earliest.

Furthermore, the State Government is also requested to take up the matter with MoEFCC for an extension of the time period by one year, until 30.09.2025, so as to obtain approval under the FC Act, 1980, for the diversion of the forest area located in the Safety Zone.

- 6. क्षेत्रीय मुख्य वन संरक्षक, सिंहभूम, जमशेदपुर ने प्रतिवेदित किया है कि अपयोजन स्वीकृत क्षेत्र 608.06 हे0 के स्वीकृत्यादेश सं0 8—69/91 एफ सी दिनांक 01.08.1996 की शर्त संख्या—4 में उल्लेखित "No Explosive should be allowed to be stored in the Forest Area" का अनुपालन के तहत वनभूमि पर अवस्थित मैगजीन को हटाने के लिये कई बार स्मार देने के बावजूद प्रयोक्ता अभिकरण के द्वारा अब तक इसका अनुपालन नहीं किया गया है । प्रयोक्ता अभिकरण का कहना है कि मैगजीन माईनिंग का एक अत्यावश्यक अंग है एवं इसे हटाया नहीं जा सकता तथा इसे यथावत रखे जाने का अनुरोध किया है । इस पर राज्य सरकार /केन्द्र सरकार निर्णय लेना चाहेगी । प्रयोक्ता अभिकरण के अनुरोध को मानने की अनुशंसा की जाती है ।

9. प्रयोक्ता अभिकरण के द्वारा मिनिरल्स सेपरेशन प्लान्ट के लिये अपयोजन स्वीकृत क्षेत्र 40.00 है0, जो 25.10.1980 के पूर्व खंडित क्षेत्र है, में स्थापित कन्वेयर बेल्ट का मोडिफिकेशन करने का प्रस्ताव है । इस कार्य के लिये नई वनभूमि की आवश्यकता नहीं है ओर न ही किसी प्रकार वनभूमि को खंडित करने का प्रस्ताव है । इसमें पेड़—पोधों को किसी प्रकार की क्षति नहीं पहुँचेगी। इस परिप्रेक्ष्य में प्रयोक्ता अभिकरण का आवेदन प्रस्ताव के साथ संलग्न है (अनुलग्नक — 11)।

इसके साथ ही टेलिंग डैम हेतु 25.10.80 के पूर्व खंडित क्षेत्र में निर्मित 8.00हैं वन भूमि के अतिरिक्त 7.00 हे0 वनभूमि की स्वीकृति भारत सरकार द्वारा दी गई है। उपरोक्त तालिका में दोनों क्षेत्रों को मिलाकर 15.00 हे0 वनभूमि अंकित किया गया है। मोडिफिकेशन प्रस्ताव की अनुशंसा की जाती है क्योंकि इसके लिये किसी नये वनभूमि का अपयोजन नहीं होगा और इस कार्य में वृक्षों की कटाई भी नहीं होगी।

- 12. प्रयोक्ता अभिकरण द्वारा समर्पित लागत-लाभ विशलेषण में वन पदार्थ का मूल्यांकन दर्शाया नहीं गया है क्योंकि वर्तमान में अपयोजन स्वीकृत क्षेत्र में अवस्थित वृक्षों के पातन की आवश्यकता नहीं है तथा रिक्लेमेशन कार्य शुरू किया जा चुका है। खिनकार्य से पर्यावरण प्रदूषित होना स्वाभिक है। खनन क्षेत्र 172.20 हे0 को छोड़कर बाकी क्षेत्र में, खासकर टाउनशीप क्षेत्र में, काफी पेड़ है तथा शेष क्षेत्र में भी काफी संख्या में पेड़ मौजूद हैं। वन संरक्षक ने अपयोजन स्वीकृत प्राप्त करना आवश्यक है।
- 13. भारत सरकार के पत्रांक 11-30/96 एफ सी (पीएफ) दिनांक 28.06.2001 द्वारा निर्गत दिशा-निर्देश के आलोक में जिला/राज्यस्तरीय मूलभूत सूचनाएँ (Basic information) समर्पित करना अनिवार्य है। क्षेत्रीय मुख्य वन संरक्षक, सिंहभूम, जमशेदपुर से अनुरोध किया जा रहा उपलब्ध करावें। प्रतिवेदन प्राप्त होने के पश्चात इसे भेजा जायेगा।

- 15. मेसर्स सेल किरीबुरू—मेघाहातुबुरू अयस्क परियोजना के पक्ष मं 3(तीन) लीज स्वीकृत है, जो लीज –1, लीज–2 एवं लीज–3 के नाम से अधिसूचित हैं । ये तीनो लीज एक दूसरे से सटी हुई हैं । मेसर्स सेल के द्वारा इन तीनों लीजों को मिलाकर एक समेकित सेफ्टीजोन मैप प्रस्ताव के साथ समर्पित किया गया है (अनुलग्नक प्लेट V), जिसमें सेफ्टीजोन क्षेत्र कुल 24.906 है0 दर्शाया गया है । प्रयोक्ता अभिकरण के खर्च पर सेफ्टीजोन क्षेत्र का निर्माण, सुरक्षा एवं सघन वनरोपण कार्य किया जायेगा तथा इसके डेढ़ गुणे क्षेत्र के समतुल्य अवकृष्ट वन क्षेत्र में वनरोपण की लागत राशि प्रयोक्ता को जमा करनी होगी । प्रयोक्ता अभिकरण द्वारा बचनवद्धता समर्पित किया गया है, जो प्रस्ताव के साथ संलग्न है।
- 16. सारण्डा वन प्रमंडल का सम्पूर्ण वनक्षेत्र सिंहभूम गज आरक्ष्य के कोर एरिय के रूप में अधिसूचित है । प्रस्तावित लीज 1 करमपदा आरक्षित वन क्षेत्र कम्पार्टमेन्ट न0 33पीव, 32, 31, 23पी0, 30पी0 एवं 14पी0 के आंशिक भाग में अवस्थित है। खनन कार्य से समीपवर्ती वनों तथा वन्य प्राणियों एंव गज वास स्थल पर प्रतिकूल प्रभाव से निपटने के लिये एक योजना समर्पित किया गया था एवं लीज—2 एंव लीज—3 के शतों के अनुपालन के रूप में मेसर्स सेल द्वारा 6,21,44,836—/रू0 विभाग के पक्ष में जमा किया गया है । प्रस्तावित क्षेत्र सिंहभूम गज आरक्ष्य के कोर क्षेत्र में अवस्थित है। खनन कार्य से वनों तथा वन्य प्राणियों पर प्रतिकूल प्रभाव से निपटने के लिये एक समेकित एवं व्यापक योजना लागू करनी होगी । इसके लिये प्रस्ताव की एक प्रति प्रधान मुख्य वन

संरक्षक, जैव विविधता संरक्षण एंव मुख्य वन्य प्राणी प्रतिपालक, झारखण्ड रॉची को भेजी जा रही है। उनका मंतब्य प्राप्त होने पर अलग से भेज दिया जायेगा ।

मेसर्स सेल किरीबुरू—मेघाहातुबुरू अयरक परियोजना के लीज —1 अपयोजन स्वीकृत क्षेत्र के टाउनशीप एवं समीपवर्ती वन क्षेत्र में अनाधिकृत रूप से अतिक्रमणकारी कभी — कभी वनों का अवैध पातन एवं अन्य गतिविधि में संलिप्त रहते हैं । विभाग के द्वारा प्रतिष्ठान को इन अतिक्रमणकारियों को हटाने के लिये कई बार निदेश दिये गये हैं। प्रतिष्ठान के द्वारा इन अतिक्रमणकारियों को हटाने के लिए ठोस कार्रवाई की आवश्यकता है। इन विन्दुओं को लेकर केन्द्रीय प्राधिकृत समिति (Central Empowered Committee) के समक्ष भी मामला विचाराधीन है। इस पर केन्द्र सरकार शीघ्र निर्णय लेना चाहेगी।

- (iii) प्रयोक्ता अभिकरण ने सूचित किया है कि माईनिंग प्लान एवं योजना प्रस्तावित माईनिंग क्लोजर की अवधि मार्च, 2010 तक प्रभावी है एवं अगले 20 वर्ष का माईनिंग प्लान तैयार कराया जा रहा है, इण्डियन ब्यूरों ऑफ माईन्स रके अनुमोदनोपरान्त माईनिंग प्लान समर्पित कर देंगे । इसक लिये प्रयोक्ता अभिकरण का बचनवद्धता प्रमाण पत्र प्रस्ताव के अनुलग्नक 3बी पर संलग्न है ।
- iv) वर्षवार भौतिक एवं वित्तीय लक्ष्य सहित रिक्लेमेशन प्लान प्रस्ताव के साथ अनुलग्नक 4 के रूप में संलग्न है ।

- vi) ग्राम सभा की अनुशंसा सहित रिज्यूलुशन की प्रति प्रस्ताव के साथ संलग्न नहीं है लेकिन इसक़ी आवश्यकता नहीं है क्योंकि पर्यावरण के स्वीकृति, जो अभी अप्राप्त है, तभी दी जाती है जब इसकी लोक सुनवाई होती है ।

I am directed to refer to above mentioned subject and to inform that the issue related to maintenance of Safety Zone was considered by the Advisory Committee (FAC) in its meeting held on 21.09.2022. The detailed minutes of the FAC meeting held on 21.09.2022 is placed on the website of this Ministry: www.parivesh.nic.in.

- 2. The Ministry has issued guidelines from time to time for the maintenance of safety zone along the boundary of mining lease. As per the guidelines dated 27.05.2015, safety zone is to be maintained in the form of 7.5 meter wide strip along the inner boundary of the mining lease. Therefore, all proposals submitted after the clarification dated 27.07.2015, includes forest area located in the safety zone unlike the situation prevailing before 2012 when area of safety zone was only needed to be indicated on the map and was not included in the area proposed for diversion.
- 3. It has also been observed that despite the standing guidelines, very few proposals of forest land located in the safety zone have been received from the State/UTs seeking approval under the Forest (Conservation) Act, 1980.
- 4. Based on the recommendations of the Advisory Committee, and approval of the same by the competent authority of the MoEF&CC, New Delhi, the following is clarified:
 - i. To enable various user agencies to align their forest land located in the safety zone with the relevant provisions of the guidelines issued by the Ministry, last opportunity is hereby being provided by the Ministry by opening a window for the user agencies to deposit NPV by 31.03.2023 along with simple interest of 12% w.e.f. 1.04.2018 onwards till the deposit is made.

ii. The user agency should submit proposal and obtain approval under the Forest (Conservation) Act, 1980 for diversion of forest area located in the safety zone by 30.09.2023.

iii. In case of failure of compliance of recommendations, mentioned under (i) and

- i. To enable various user agencies to align their forest land located in the safety zone with the relevant provisions of the guidelines issued by the Ministry, last opportunity is hereby being provided by the Ministry by opening a window for the user agencies to deposit NPV by 31.03.2023 along with simple interest of 12% w.e.f. 1.04.2018 onwards till the deposit is made.
- ii. The user agency should submit proposal and obtain approval under the Forest (Conservation) Act, 1980 for diversion of forest area located in the safety zone by 30.09.2023.
- iii. In case of failure of compliance of recommendations, mentioned under (i) and (ii) above, possession of forest land located in the safety zone will be considered as violation of the FC Act, 1980 and appropriate penalties will be imposed on defaulting user agencies.
- iv. The IROs concerned will monitor the compliance in the matter and submit six monthly report to the Ministry.

In this regard, keeping in view the request received from the Secretary, Ministry of Steel for extension of the time limit for obtaining approval for diversion of forest land within safety zone, the matter was reconsidered in the Ministry and placed for consideration before the Advisory Committee in its meeting held on 14.11.2023. Based on the recommendations of the Advisory Committee, and approval of the same by the competent authority in the MoEF&CC it has been decided that:

- In such cases where the proposal for the diversion of forest areas within the safety zone has been submitted by 30.09.2023 the time period for obtaining approval under FCA,1980 is extended further till 30.09.2024.
- II. In cases where the proposal for the diversion of forest land within the safety zone

- has not been submitted by 30.09.2023, the User agency shall deposit one-time penal NPV + Normal NPV and obtain the approval under FCA,1980 for the forest areas within the safety zone latest by 30.09.2024.
- III. Further, in case the required compliance is not done even till 30.09.2024, approval under FCA, 1980 in such cases shall be considered deemed to be in abeyance.
- IV. As provided in the guidelines issued vide letter dated 07.11.2022, the deposit of NPV in all cases is to be made along with simple interest of 12% w.e.f. 1.04.2018 onwards till the deposit is made.
- V. The IROs concerned will monitor the compliance in the matter and submit six monthly report to the Ministry.
