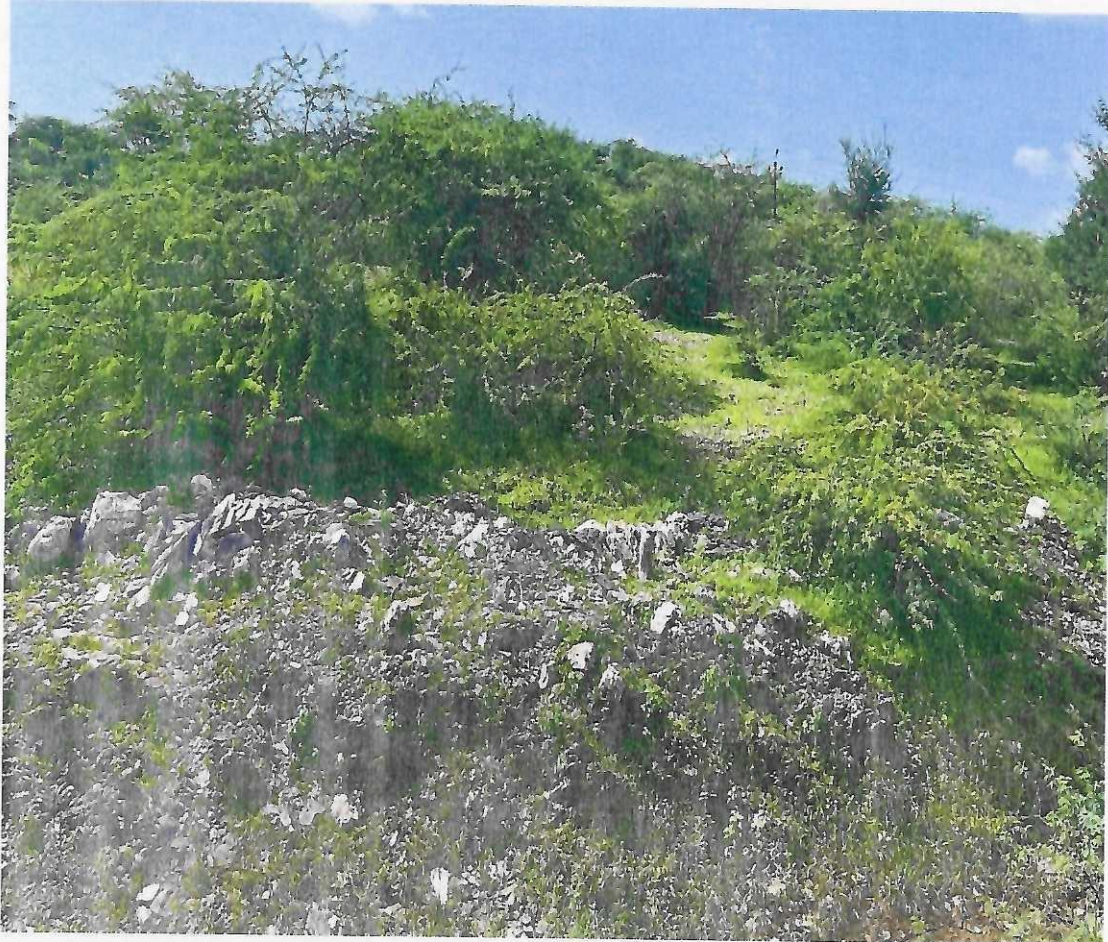


- 8 **Compensatory afforestation:** The compensatory Afforestation (CA) is proposed on Degraded Forest Land (DFL) in double the extent of the forest land proposed for diversion, as the User Agency is Airport Authority of India (AAI) a Central Govt. Undertaking. The details of the DFL in 13 patches (Some of them are shown in photographs above) are as:

- 19 Following are the main information's relating to the project:
 i. The complete 466.592 ha area proposed for diversion fall within notified Buffer area of Ramgarh-Vishdhari Tiger Reserve (Notified by the Rajasthan Govt. on 16.05.2022) and within 10 Km of Chambal Ghariyal Sanctuary, therefore the National Board of Wildlife clearance is required.
 ii. 400 KV transmission line of Power Grid Corporation of India Ltd (PGCIL) is passing through the proposed land for diversion. Officer present during inspection told that they are going to shift the transmission line and proposed shifting of transmission line will be passing through forest land. So far PGCIL has not submitted any proposal for diversion under FCA.
 iii. Out of 2276.29 ha forest land in Jhakhmund Forest Block, Dabi – Range of Bundi Forest Division 466.592 ha forest land is proposed for New Green Field Airport. Two fragmented patches of forest land at Northern side of the proposed airport are of about 33.5 ha. and 137.01 ha. are left which will be prone to encroachment. It is proposed that User Agency to construct boundary wall for these two patches for saving the fragmented forest area from encroachment.
 iv. CA is proposed in Degraded Forest Land in 13 patches which are at different locations spread in Dabi and Hindoli Ranges of Bundi Division and situated far away from one another.
 v. All CA land infested with *Prosopis juliflora* and Lantana. There is no provision seen for removal of these invasive species in CA plan. Without removal of these invasive weeds it will be difficult to plant 1000 seedlings/hectare.
- 20 **Recommendations:** The proposal is recommended for approval with following conditions:
 i. It is proposed that User Agency to construct boundary wall for these two fragmented patches of about 33.5 ha. and 137.01 ha. In the northern side of the proposed land for diversion for saving them from encroachment.
 ii. Required Wildlife clearance from the NBWL may be taken.
 iii. The proper provision for removal of *Prosopis juliflora* and Lantana has to be incorporated wherever necessary in CA plantations.
