महोदय,

उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत प्रतिउत्तर का ध्यानापूर्वक अवलोकन करने के पश्चात पाया गया कि राज्य सरकार द्वारा अभी भी कमियों की संतोषजनक अनुपालना प्रस्तुत नहीं की गई है। प्रतिउत्तर में अभी भी निम्नलिखित कमियां पाई गई हैं:-

1. In reply to observation no. 1, it has been submitted that revised CA scheme has been uploaded in Part-II. However, observation point was to rectify the "name of proposed CA land which is mentioned as OTHERS". Therefore, reply may be reviewed and rectification in the name of proposed CA land in Suket Forest Division in Part-II, Para-13(i) in table may be carried out.
2. In reply to observation no. 2, it has been submitted that CCF concerned has submitted that proposed CA land is in possession of HP Forest Department. Copy of Working Plan is uploaded in Part-I. However, Copy of Working Plan as documentary proof is not found uploaded.
3. Regarding reply of observation no. 02, of REC, revised Cost Benefit ratio is uploaded in additional information. However, in revised CB ratio, Benefit to Cost ratio is mentioned as 171.14:1, which seems to be in very high side. Therefore, same may be reviewed and revised be uploaded only at designated location of Part-I, i.e-Para-G.
4. In reply to observation no. 03 of REC, uploaded dimension wise detail of each tower in tabulated form is in blurred form and is not readable. Therefore, clear dimension wise detail of each tower in tabulated form in visible form may be uploaded.
5. Regarding reply of observation no. 08, of REC, it has been submitted that records of consultations and meetings with Gram Sabha(s) of concerned villages uploaded in Part-I. However, same is not found uploaded in PARIVESH portal at designated location.
6. In reply to observation no. 4, it has been submitted that the abstract of tree enumeration has been uploaded in Part-II. However, as desired abstract and enumeration detail of trees proposed for felling on Bilaspur Forest Division are not found uploaded.

अतः अनुरोध है कि उपरोक्त कमियों की संतोषजनक अनुपालना सुनिश्चित करने के उपरान्त ही प्रस्ताव को इस कार्यालय में जमा किया जाए।

यदि चाही गई सूचना पत्र जारी होने की तिथि के 60 दिनों के भीतर (अधिकतम 90 दिन) इस कार्यालय में प्राप्त नहीं हुई तो प्रस्ताव को निरस्त किया जा सकता है।
