The area contains very less vegetation and mainly barren hills with CD less than 0.4. The vegetation containing *Tectona grandis*, *Ficus bengalensis*, *Acacia nilotica*, *Ziziphus spp.*, *Azadirachta indica*, *Lantana camara*, *etc.* were observed. The area / forests primarily were under degraded condition and forest was encroached or given under FRA.

viii. Background note of the proposal:

The project needs diversion of 21,978 ha of Forest Land and 21,641 ha of non-forest land for the prospecting of Petroleum and Natural Gas.

Entire area will be used for prospecting via shot holes technique. The final outcome of the exercise will give the amount of Petroleum and Natural Gas in the Damoh area specifically Vindhyan basin rock / system.

- ix. Compensatory Afforestation : As the prospecting will not have any permanent changes in land, No compensatory afforestation is required for the purpose of forest land to be used for exploratory drilling as per provisions of Guidelines of MoEF&CC, Government of India vide F. #### xxii. Observations / comments of DCF(C), RO, Bhopal:

- a) The proposal is of 21,978 ha prospecting and very limited information is made available by the State Govt. of Madhya Pradesh.
- b) This office has gathered the details of the compartment from MP forest website (<u>http://intranet.mpforest.gov.in/MPFD15/login.aspx?ReturnUrl=%2fMPFD15%2fWPMS%2f</u> <u>Workingplanlibrary%2fDataUpdation.aspx</u>) and DSS portal. The DSS report is enclosed herewith (A-I).
- c) As per DSS, a 82 nos. compartments for Damoh & Katni forest divisions are involved in the present proposal in the PML / block lease boundary / exploration boundary (referred as *PML boundary*). The presence of the MDF was noted over 60 nos. compartments (7 nos. compartments in Katni FD and 53 nos. compartments in Damoh FD) out of 82 nos. compartments.

- c) The proposal attracts the MoEF&CC guideline F. No. 5-3/2017-FC dated 09/05/2018 and F. No. 5-3/2007-FC dated 24/12/2018.
- **d**) SIR of DFO (Damoh) reports involvement of 71 nos. of compartment and SIR of DFO (Katni) doses not given the list of compartment involved in the project.
- e) The DSS analysis revels that:
  - i. There is approx. 30 m shift in *PML boundary* submitted on *e.portal* and Compact Disc (*PML boundary*) along with the proposal.
  - **ii.** Some of bore holes lie in the water body and river.
  - iii. As per the DSS analysis on KML file (CD along with proposal) of *PML boundary* comes to be 28,368.04 ha, the forest area in PML boundary comes to be 15,309.11 ha in place of 21,978 ha as given in the proposal. The nos. of bore holes in the forest area inside the *PML boundary* comes to be 3,785 nos. in place of 5,940 nos as given in the proposal. A total of 2,155 nos. of bore holes are marked / fall outside the *PML boundary*. The matter was discussed with the representatives of ONGC Ltd. and they have submitted the justification for the same vide ONGC ltd letter dt. 29/01/2019 copy enclosed (A-II).

**f**) No tree are marked for feeling in the proposal, however, no tree felling shall be carried out during implementation of the project.

## xxiv. Recommendations of APCCF(C), R.O., Bhopal :

In view of the details mentioned in the site inspection report of Dy. Conservator of Forest (C), undersigned recommends the proposal for obtaining approval under Forest (Conservation) Act 1980 for prospecting of Oil and Natural Gas for 21,978.00 hectares of forest land in Damoh PML for drilling of 5,940 Boreholes of 04" diameter in favour of M/s. GM Chief Geological Services Frontier Basin Oil and Natural Gas Corporation Limited Dehradun, Damoh Forest Division State of Madhya Pradesh under Forest (Conservation) Act, 1980 subject to the above given observation and condition.

In view of the above facts related to the proposal, it is proposed that proposal with the Site Inspection Report as submitted by the Regional office (Western Zone), Bhopal, may be submitted to the FAC for its consideration in its forthcoming meeting scheduled to be held on **21.02.2019**.
