

Sub: Proposal to obtain approval under the Forest (Conservation) Act, 1980 for prospecting of Oil and Natural Gas for 1321.44 hectares of forest land in Damoh PML for drilling of 2753 shot holes of 04” diameter in favour of M/s. GM Chief Geological Services Frontier Basin Oil and Natural Gas Corporation Limited, Kolagarh Road, Dehradun, Damoh Forest Division State of Madhya Pradesh.-regarding.

- The Addl. Principal Chief Conservator of Forests (Land Management) and Nodal Officer, the Forest (Conservation) Act, 1980, Government of Madhya Pradesh vide their letter No. F-1/FP/MP/MRL/22/2017/10-11/714 Bhopal dated 12th March, 2018 (Pg. 1-130/c) forwarded a fresh proposal to obtain prior approval of the Central Government, in terms of the Section-2 of the Forest (Conservation) Act, 1980 for prospecting of Oil and Natural Gas for 1321.44 hectares of forest land in Damoh PML for drilling of 2753 shot holes of 04” diameter in favour of M/s. GM Chief Geological Services Frontier Basin Oil and Natural Gas Corporation Limited, Kolagarh Road, Dehradun, Damoh Forest Division State of Madhya Pradesh.

3. The lease shall be valid for a period of 07 years with effect from 10.02.2015 to 09.02.2022 as per the Ministry of Petroleum & Natural Gas, Government of India, New Delhi vide his letter No. O-12012/104/2004-ONG-II dated 12.05.2015 (Pg. 20-21/c).
4. The user agency has undertaken to adhere to the provisions of Forests (Conservation) Act, 1980 & its amendments. No trees will be cut for the drilling or boreholes and necessary shifting of proposed points will be done to locate the boreholes in the open land in the forest areas. Only existing path will be used to access the proposed points and no new paths will be constructed.
5. The proposal for prospecting No CA scheme is required for the instant project.
6. The Regional Office, Bhopal vide their letter No. 6-MPA06/2018-BHO/037 dated 08.11.2019 (Pg. 132-136/c) has submitted a Site Inspection Report as carried by the DCF, Bhopal.
7. The Site inspection was carried out by B. Abhay Bhaskar, DCF(C), RO, Bhopal and the representative of MP Forest Department and ONGC Ltd., Camp Damoh were present.

As per Part-II, Canopy Density is 0.1 to 0.4 & Eco Class - VB. The area is protected and reserved forest.

The area contains very less vegetation and mainly barren hills with CD less than 0.4. The vegetation containing *Tectona grandis*, *Ficus bengalensis*, *Acacia nilotica*, *Ziziphus spp.*, *Azadirachta indica*, *Lantana camara*, etc. were observed. The area / forests primarily were under degraded condition and forest was encroached or given under FRA.

- viii. Background note of the proposal:

The project needs diversion of 1321.44 ha of Forest Land and 6679 ha of non-forest land for the prospecting of Petroleum and Natural Gas.

Entire area will be used for prospecting via shot holes technique. The final outcome of the exercise will give the amount of Petroleum and Natural Gas in the Damoh area specifically Vindhyan basin rock / system.

- ix. Compensatory Afforestation : **As the prospecting will not have any permanent changes in land, No compensatory afforestation is required for the purpose of forest land to be used for exploratory drilling as per provisions of Guidelines of MoEF&CC, Government of India vide F. No. 11-96/2009-FC dated 04.07.2014. The Govt. of MP vide letter dt. 12/05/2018 has submitted that no CA is being proposed.**

The inspection was carried out on 04/01/2019 at Compartment no. 262, 263, 264, 265 and 268.

- a) The NOC of concerned Gram Panchayat / FRA certificate for the concerned District Collector shall be submitted.
- b) In accordance to the MoEFCC guideline F. No. 5-3/2017-FC dated 09/05/2018, the NPV shall be charged.
- c) The DSS analysis reveals that:
 - i. Some of shot holes lies in the water body and river.
 - ii. As per the DSS analysis on KML file of lease boundary (rectangle shape), forest compartment and shot holes, the lease boundary comes to be 8,000.28 ha, the forest area comes to be 900.50 ha and nos. of shot holes in the lease boundary comes to be 1,095 as some of the shot holes are marked outside the lease boundary.

xxiii. Recommendations of APCCF(C), R.O., Bhopal :

In view of the details mentioned in the site inspection report of Dy. Conservator of Forest (C), and recommends the proposal for obtaining approval under Forest (Conservation) Act 1980 for prospecting of Oil and Natural Gas for 1321.44 ha of forest land in Damoh PML (Nohta-Damoh-Jabera PML) for drilling of 2753 shot holes of 04” diameter in favour of M/s. GM Chief Geological Services Frontier Basin Oil and Natural Gas Corporation Limited Dehradun, Damoh Forest Division, State of Madhya Pradesh under Forest (Conservation) Act 1980 subject to the above given observation and conditions.

In view of the above facts related to the proposal, it is proposed that proposal with the Site Inspection Report as submitted by the Regional office (Western Zone), Bhopal, may be submitted to the FAC for its consideration in its forthcoming meeting scheduled to be held on **21.02.2019.**
