2. Further, it is requested to analyze the requirement for 12.95 ha forest land proposed for (i) Dam office & guest house (4.50 ha) (ii) Dam view point (8.45 ha) and (iii) component namely Utility proposed on 1.054 ha. of forest land which seems non-site specific in nature.
