

- 7. Whether proposal involves any construction of buildings (including residential) or not. If yes, details thereof: No. User Agency informed that they will not construct any permanent structures in forest area proposed for diversion and will use the temporary containers at the mining site.
- 8. Total Cost of Project at Present Rates: Rs.3068.445 Lacs
- 9. Wildlife: As per the part II submitted from the division the wildlife present in and around the proposed forest land diversion are: Common Langur, Golden Jackal, Common Mongoose, Striped Hyena, Indian Porcupine, Monitor Lizard, Indian Peafowl, Gray Partridge, Indian Hare, Pale Hedgehog, Common Garden lizard, Common Indian monitor lizard, Leopard etc.

Compensatory Afforestation (CA) towards instant proposal has been proposed to be carried out in three patches and one of the CA patches namely Village: Pahada comprising 13.5 ha land is within the forest	 Pahada land is having area of 45.50 ha instead of 13.5 ha as given EDS. It was informed that as per the revenue records the 45.5 ha. land for CA falls in khasra nos 964,964/1, 1457,1457/10, 2070 of revenue village Pahada and the land belongs to State revenue department. Proper analysis of the area was carried out by cross checking all adjoining block files and maps of Pahada block, Mobi Block and Meva Block. Superimposing the revenue maps and forest maps in scale was carried out and it was found that earlier shown forest department

Further, 45.5 ha of revenue land for CA in Village Pahada has been again jointly verified on ground with the revenue and forest officers and it is found that above said land belongs to the revenue department and located completely outside the forest boundary. 4. In the village Pahada 45.5 ha NFL allotted not 13.5 ha. 5. Therefore, a request for correction in KML of forest boundaries was made to the state authorities. In this regard, it has now been informed that the essential correction has been done in the forest block boundaries and the corrected forest block boundaries have been uploaded on the State Forest Department website. Earlier shown non forest land of Pahada village was excluded from updated KML of forest areas.
2.	Few settlements, small area under agriculture and existence of road are found in the proposed forest land for diversion. Moreover, encroachment in form of agriculture and the settlements are also visible just outside the boundary of proposed forest land for diversion. This requires justification and clarification.	DFO during inspection informed that some times tribal people are carry out some agricultural activities seasonally but they are removed and there is no encroachment now.
3.	As per DSS analysis, out of identified 75 ha. nonforest land for CA, 13 ha. Is Moderately Dense (MDF),39 ha. is Open Forest (OF), 02 ha is Scrub and remaining 21 ha is non-forest. Further, the State Govt has submitted the site suitability certificates intimating that the NFL proposed for CA is suitable for planting. Keeping this in view the justification for submitting details of 85	The NFL proposed for CA is found to be suitable for carrying out the CA plantation and already have good number of trees and only about 200 trees per hectare is possible to plant. State Govt. proposed to carry out remaining CA plantation on 85.00-hectare DFL in Pratapgarh Division to accommodate the remaining plants.

4.	The State Govt. has not provided the KML file of 85 ha degraded forest land identified for the purpose of CA in forest block-Sukad (RF) of village- Dhawada, Tehsil- Chotisadri, District-Pratapgarh, Rajasthan.	KML of 85 ha degraded forest land has been uploaded now.
5.	An area of 0.75 ha is proposed to be used for Roads and Buildings, however the nature of buildings proposed to be constructed has not been given. The State Govt. shall explore the possibility of carrying out building construction on non-forest land.	In this regard a detailed reply from user agency was sought of. It is submitted by user agency that out of 0.75 ha forest area proposed for roads and buildings in the proposal. 0.71 ha will be used for roads essentially required to carry out mining activities such as extraction and transportation of mined out mineral while only 0.04 hectare (400 square metre) area is to be used for temporary portable structures such as workshop, storage of tools and plants, rest shelters and small office essential on site to carry out mining activities. All these structures will be temporary in nature and will be removed at the time of closure of mining activities and before handing over the proposed forest land back to the State Forest Department. An undertaking submitted by user agency in this regard is attached here with.

28. Recommendations of the site inspecting officer: The proposal for diversion of 74.2490 ha Forest Land in favour of RDSA Mining LLP for opencast Marble Mining in Revenue Village- Danta, Tehsil- Pipalkhunt, District- Pratapgarh, Rajasthan is recommended with following specific conditions:

- 1. The User Agency will not use the diverted forest land for construction of buildings and other non-site-specific activities and will use temporary structures only.
- 2. Embankment of sufficient height will be constructed by the User Agency along the bank of the River Mahi so the muck and waste will not enter into the river.
- 3. Muck will not be disposed on forest/charagah land outside the proposed diversion land area.

4. Six feet boundary wall shall be constructed along the boundary of the Non-Forest Land (NFL) proposed for CA in all the three patches towards the habitation and agriculture fields to prevent encroachment at the cost of user agency.
