महोदय,

In reference to the subject cited above, it is to inform that the above referred proposal is submitted to Integrated Regional Office, Shimla for diversion of 7.3722 ha of additional forest land in already approved project consisting of 63.5015 ha of forest land for Shongtong Karchham Hydro-Electric Project (402 MW) in Kinnaur district by the Ministry of Environment, Forest and Climate Change, New Delhi vide File no. 8-78/2010-FC dated 14.11.2012.

The justification mentioned for additional land requirement is due to enhancement in the existing capacity of already approved HEP from 402 MW (63.5015 ha) to 450 MW, usage of already diverted dumping sites used by BRO and restriction imposed by the Army Authorities for construction activities within the boundary of 1200 yards.

Since the extant proposal is linked with already approved HEP Project (vide File no. 8-78/2010-FC dated 14.11.2012) by MoEF&CC, New Delhi, therefore, the proposal is hereby returned with the request to kindly take up the matter directly with MoEF&CC, New Delhi.
