Sub: Diversion of 0.4908 ha forest land in favour of Rural Management & Development Department (RM&DD) for construction of rural connectivity road from Sakyong PWD to Tinek Chisopani Dokey Gaon in East district of Sikkim.

Sir,

Please refer to letter No.1816/FCA/F&ED/2019/632 dated 12.11.2021 on the above cited subject. The reply furnished vide above cited letter of the additional information sought by this office vide letter of even number dated 28.06.2021, has been examined and observed that the following documents/information are still required to upload in online application of the proposal for further processing:

- i. As per uploaded Kml file, the forest land proposed for diversion is calculated 2.44 ha instead of 0.4908 ha. Correct kml file may be uploaded.
- ii. SoI map showing proposal diversion area with GPS coordinated is not uploaded. It may be uploaded.
- iii. As per Decision Support System, proposed CA land is Open to Moderately Dense forest cover. Proposed CA area may be rechecked.
- iv. The proposed diversion area is near to river. Therefore, quantity of Muck to be generated with GPS coordinates of muck disposal area/ Muck disposal plan and distance from river area is to be submitted.
- v. The RoW and length of road is to be mentioned clearly.
- vi. Two different certificates of cost of cutting felling logging and transportation of the project affected trees of Rs.1,39,600/- & Rs.95,280/-has been submitted. Correct one may be uploaded.

- vii. In cost cutting form, mentioned 97 nos. of pole and 50 nos. bamboo which is not clearly mentioned in site inspection report submitted by the DFO. Updated Site Inspection Report needs to be uploaded.
- viii. Part-V of the proposal for diversion of 1.044 ha forest land for construction of Rural Connectivity Road from SPWD to Rateypani (Passi) is uploaded in this proposal, which needs to be corrected.

Therefore, it is requested that above mentioned documents/ information may be kindly uploaded in the PARIVESH portal for further consideration of the proposal.
