- iii. The State Govt. is requested to submit the status of the CA plantation and KML file of the previous CA lands identified i.e. 111 ha in lieu the diversion of 110.87 ha. The State Government is also requested to forward the copy of the original notification declaring the non-forest land as PF/RF under Section 4 or Section 29 of the Indian Forest Act, 1927, or under the relevant section of the State Forest Act as the case may be.
- iv. The State Govt. is also requested to provide the status of plantation carried out in Degraded forest land of 7.356 ha wrt the proposal for re diversion of 3.678 ha. of forest land for widening of road in Kothaguda R.F. in favour of Greater Municipal Corporation, Hyderabad
- v. The State Govt. is requested to forward the compliance report with respect to

this Ministry's Stage-II letters dt 23.03.2006 (wrt Diversion of 110.87 ha) and dt 21.08.2013 (wrt re-diversion of 3.678 ha).

- vi. The State Govt. is requested to submit the details of violation of FC Act and the Action taken report.
- vii.The State Govt. is requested is requested to submit the justification since the proposed activity is non-site specific and against the guidelines issued by this Ministry wrt to Eco-tourism.

In view of above the State Govt. is requested to kindly furnish the above mentioned information/documents for further consideration of the proposal.
