Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **3.27 ha** of forest land for non-forestry purpose in accordance with section 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980.

2. After careful examination of the compliance report submitted by the UT Administration vide Letter No. FST-Land/FC/11/2026-02 dated 10/03/2026, it has been observed that certain essential information is still required to be furnished.

- I. Density of the proposal is 0.7. NPV should be calculated as per very dense rate but amount of NPV deposited as per dense category rate. In view of the above, the revised NPV calculation sheet, duly prepared in accordance with the applicable VDF rates, along with the challan/receipt is required to be furnished.
- II. In response to Condition No. 2 (A) (vii), it is noted that the muck disposal plan has still not been submitted. The User Agency is required to upload and submit the muck disposal plan prior to the grant of Final Approval.

3. The compliance to the above may be submitted within **30 days** from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
