With reference to the subject and references cited above, it is to inform that the subject proposal involving certain violation and additional information submitted by the State Government has been examined and forwarded to the Ministry in the light of **Rule 10(5) of the Van (Sanrakshan Evam Samvardhan) Rules, 2023. The Competent Authority in the Ministry have approved for according final approval provided the following conditions are complied with by the user agency/state government:**

1. The User Agency shall pay the penal NPV equal to **five** times the normal NPV over the forest area involved in the project.
2. Complete compliance with the conditions stipulated in the *In-principle* approval.

In view of the above, it is requested that the proposal may be submitted after realizing 5 times of penal NPV along with complete compliance for the Stage I conditions to enable further processing for grant of final/Stage II approval by the Regional Office.
