Sub: Diversion of balance forest land of 11.006 ha (safety Zone – 9.778 ha and area for public purpose – 1.228 ha) excluding 177.517 ha of already diverted forest land out of total forest land of 188.523 ha within the applied mining lease area of 188.523 ha for Iron, Manganese and Bauxite Mining in village Kalmang, Jaldihi, Sidimba and Tantigram (KJST) under Koira Tehsil of Sundargarh District by Sri Prabodh Mohanty, Legal heir of Late S. N. Mohanty.

Sir,

I am directed to refer to the State Government's letter No. 5192/9F(MG)-161/2007 dated 16.03.2019 forwarding compliance of conditions stipulated in Stage-I approval dated 29.06.2017 towards instant proposal. With regard to NPV, the State Government in compliance to condition no. (7) of Stage-I clearance dated 29.06.2017 informed that the User Agency has deposited Rs.13,76,21,790/- towards NPV over 188.523 ha of retained forest land as per following details:

As above, a total of Rs. 13,72,72,870/- (Rs.1,09,12,120/- + Rs.11,90,27,250/- + Rs.73,33,500/-) has been realized for NPV for an area of 187.295 ha (18.814 ha + 158.703 ha + 9.778 ha) out of total forest land of 188.523 ha. Thus, remaining area comes to 1.228 ha (188.523 ha – 187.295 ha) for which Rs. 3,48,920/- is being realized from user agency, whereas minimum rate of NPV Rs. 4,38,000/-. Therefore, it shows that the NPV cost as admissible has not been deposited towards instant proposal.

In view of above, the State Government is requested to clarify about NPV deposits along with documentary evidence for admissible amount to this Ministry for further consideration of the proposal.
