Sub: Diversion of 0.0013 ha of forest land for approach road to M/s Jain Bamboo and Wood Works (Saw Mill) Situated at village Bhunga on Hoshiarpur road to Dasuya road, km 22-23 LHS, Tehsil Bhunga and under Forest Division and District Hoshiarpur, Punjab. (Online proposal no FP/PB/Approach/146580/2021)-regarding

महोदय,

मुझे आपका ध्यान उपर्युक्त प्रस्ताव की और दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए 0.0013 हेक्टेयर वन भूमि की मांग की गई है।

2. इस कार्यालय के दिनांक 06.03.2023 के भेजे गये पत्र के माध्यम से कुछ जानकारियाँ मांगी गई थी जिसके सन्दर्भ में आपके द्वारा अनुपालन प्रतिवेदन दिनांक 05.05.2023 को इस कार्यालय में प्राप्त हुआ है इसमें शर्त संख्या i, ii, vi, vii और viii के संदर्भ में भेजी रिपोर्ट स्पष्ट नहीं है। कृपया निम्न शर्तों की अनुपालना सुनिश्चित करें:-

- i) As per NOC from PPCB and license granted by the Forest Department, the said industrial unit is in operation since 2015 and the CTE is also of 2015. It appears that the said unit was in operation since long and only recently, the proposal for FC diversion has been processed by the State Government. The State Government needs to send clarification for the inconsistency.
 - ii) The action against UA is not mentioned and what action has been taken against erring forest official for not protecting forest from commission of violation has also not been provided. Hence, the detailed violation report alongwith Forest Offence Report needs to be submitted.
 - iii) As per Google earth imagery, more than 70 metre length of strip has been devoid of any vegetation and appears to have been used by the UA, whereas only 6 m length of the strip forest has been shown in latest calculation of the forest diversion. Why department has not taken the whole area of strip forest and why the department has not taken cognizance of the encroachment since 2015, needs to be clarified.
 - iv) Nowhere is mentioned that the distance has to be measured from Nearest Block forest. For all approach access, the distance from strip forest is measured and it should be Zero, and accordingly needs to be corrected.
