Sir,

I am directed to refer to Government of Jharkhand's letter No. 3-VAN BHOO MI-29/2008-1775/VP dated 05.04.2016 forwarding compliance report on the conditions stipulated in Stage - I letter dated 18.10.2010 read with letter 07.05.2014.

2. It is further informed that the Management Plan for Sustainable Mining in Saranda and Chaibasa in Singhbhum District, Jharkhand has been approved by the Competent Authority and a copy of the same has been uploaded on Ministry's web portal [www.forestclearance.nic.in](http://www.forestclearance.nic.in). In addition to this a copy of approved Management Plan for Sustainable Mining was forwarded to the State Government vide this Ministry's letter No. 11-65/2014-FC dated 08.06.2018.

In view of above, before examining the proposal further in the Ministry, the following documents / information are required:

- (i) Shape / KML file of the proposed diversion of forest land along-with sites identified for CA purpose.
- (ii) Compartment-wise details of proposed diversion of forest land falls in prescribed Mining zone in approved Sustainable Mining Plan.
- (iii) Recommendation of State Government for the instant proposal taking into consideration the approved Management Plan for Mining.
- (iv) The duly verified lease document specifying the validity period of lease.
- (v) A certificate from the Government of Jharkhand indicating that the proposal in accordance with the approved Sustainable Mining Plan.
