I am directed to inform that the State Govt. of Telangana vide their letter No. 1069/For. I (1)/2019 dated 18.04.2019 submitted the above subject proposal for seeking prior approval of the Central Government in accordance with Section-2 of the Forest (Conservation) Act, 1980 and the Regional Office, Chennai vide this Ministry's letter of even number dated 15th May, 2019 requested to carry out the Site Inspection of the said proposal and submit a detailed report to this Ministry. But the site inspection report(SIR) is still awaited.

Para 7(b) of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No. 5-2/2017-FC dated 28.03.2019 states that "in case a proposal involves forest land more than one hundred hectares or renewal of lease, Regional Office shall within forty-five days of the receipt of the proposal complete in all respects from the State Government or the Union Territory Administration, as the case may be, inspect the forest land proposed to be diverted and prepare a site inspection report". But in the instant case, the admissible time limit is already over.

In view of above, it is again requested to kindly carry out Site Inspection of the proposed Forest area immediately and to send SIR to this Ministry for further processing.
