SITE INSPECTION REPORT IN RESPECT OF DIVERSION PROPOSAL FOR SEEKING PRIOR APPROVAL OF THE CENTRAL GOVERNMENT UNDER SECTION 2(II) OF THE FOREST CONSERVATION ACT, 1980 IN FAVOUR OF ODISHA MINING CORPORATION LTD FOR NON FORESTRY USE OF 168.948 HA OF FOREST LAND ADJACENT TO SOUTH KALIAPANI MINES FOR DUMPING OF OVERBURDEN OF SOUTH KALIAPANI AND SUKURANGI CHROMITE MINES UNDER CUTTACK FOREST DIVISION, ODISHA

- 4. There are certain exposed rocky patches devoid of vegetation observed where no mining has been carried out

From the above observations, it is concluded that no violation of the FC Act, 1980 has been noticed during field inspection.
