SITE INSPECTION REPORT

Proposal under Forest (Conservation) Act 1980 for diversion of 192.36 ha. of forest land for Magadh Open Cast Coal Mines project in favour of M/s CCL in Chatra district of Jharkhand.

A proposal to divert 192.36 ha of forest land towards Magadh Open Cast (Coal) Mining Project is under examination as per provisions of Forest (Conservation) Act 1980.

Ministry (MoEFCC) while processing this proposal of central Coalfield Limited (CCL) requested this office (IRO/RO Ranchi) to inspect the area as per FC rules 2003 with particular emphasis on following points:

- Examination of area proposed for diversion.
- Examination of CA area proposed
- Status of compliance of conditions stipulated in the approval granted in past to this project along with violation by erstwhile user agency.
- Legitimacy of land use proposed by user agency specially for over burden dump.

Accordingly, this office undertook site inspection along with state Forest officials u/a representatives on 12th April 2023 and detailed report on the above points was sent on 21/4/2023.

As in the proposal two types of forest lands are involved namely Protected Forest & GMJJ under administrative control of State Forest Department (SFD) and State Revenue Department (SRD) respectively, the site inspection was focused on Protected Forest area only because no representation of State Revenue Department was there during site inspection who have jurisdiction over GMJJ lands.

Due to this, violation done by U/A on GMJJ land was not assessed. The same was neither informed by SFD during that visit nor by U/A representatives.

Therefore, ministry vide its letter dated 28th April 2023 requested this office to visit the area again to examine the violation over GMJJ lands. All the patches of CA were also requested to be examined.

Hence sites (diversion and CA) were re-visited by RO, Ranchi during 3rd – 5th July 2023.

The site inspection in respect of the project was done by the team of IRO/RO Ranchi including Sh. Shashi Shankar, Assistant Inspector General of Forests and Dr. Surajit Panda, Sr. Technical Associate (GIS-DSS) along with Md. Saba Alam Ansari, IFS (DFO, Chatra South FD) for verifying the facts related to <u>the actual ground situation of GMJJ</u> <u>land proposed diversion, including the CA lands</u>. <u>Details of broken and unbroken GMJJ land of propose for diversion and</u> <u>ground situation</u>

As explained in the previous report of IRO dated 21/4/2023, the total lease area of the project (in Chatra District) is 495.9 Ha consisting of 219.88 Ha Non-forest land and 276.04 Ha Forest land. 96.72 Ha of Forest-land from this has already been diverted for the project by Final Approval dated 18/10/2010. 13.04 Ha of this diverted land now is carved from this project and is incorporated in adjacent Sanghmitra Project by the same Project Proponent owing to certain logistic conveniences. Therefore, 83.68Ha forest land which consists of 12.46Ha of notified Protected Forest & 71.22 Ha of Gair Majarua Jubgle Jhari (GMJJ) is already diverted in 2010 and mining is happening in the diverted as well as non-forest land in the project area.

In the present proposal, the total proposed forest area of Magadh Open Cast Coal Mines project is 192.36 ha. Out of 192.36 ha., 135.07 ha. is Gair Majarua Jubgle Jhari (GMJJ) land. This GMJJ land is not under the jurisdiction of DFO. The GMJJ land is under the administrative control of State Revenue Department (SRD) and mostly under Khatedari rights and occasionally discretely distributed as small land parcels along the non-forest lands. Therefore, DFO - Chatra South informed that it becomes tedious to even identify these GMJJ land for SFD officials as they don't have the relevant land records and do not administer, control or possess jurisdiction of GMJJ land. He further added SFD's inability in taking cognizance of any violation of GMJJ land. He further added that only 57.29 ha of total applied forest land is under administrative and statutory control of State Forest Depart (SFD) is situated in Northern part of the lease area which was shown to the inspecting IRO Team in its previous visit and where there is no violation of FCA in relation to the project.

The inspecting team reiterated the mandate of the re-visit and requested to visit the GMJJ sites where violation has been done/reported. Accordingly, the areas were visited.

It was informed by user agency that after the final approval dated 18/10/2010, the mining was started in two extremities (Eastern Part and Western Part) of the lease in diverted as well as non-forest lands. Two box-cuts were made, in Eastern Part (Zone-A)-at the Masilaung Site and in Western Part (Zone-B) at Saradhu site as depicted in the imagery below.

As the mining progressed, the excavation pits horizontally expanded and continued over GMJJ lands for which FC approval were not obtained. Representative of user agency apprised that since non-diverted GMJJ land were coming in between diverted lands and they were ocularly no different than non-forest land, the mining inadvertently continued on them also. He further added, all the required formalities on GMJJ lands were completed/settled from the State Revenue Department and the individuals under who's rights such GMJJ rested. The inspecting team enquired about the involved dichotomy of not recognizing the non-diverted GMJJ and yet, claim of settling the rights over them. To explain further, the user agency presented the production data (Monthly) from the above two zones to establish that the mining activities were many times stopped to avoid further mining in non-diverted forest lands. The Production Data as submitted by user agency is attached herewith as Annexure-I. The production data depicts that intermittent stoppage of mining cannot be attributed to extant FC approval as the same is yet to be accorded.

Further, the inspecting team assessed the extent of violated land. Since, the pits were found water logged in Zone-A (Masilaung Site), the claim of user agency that the mining activity is ceased since last two years appeared correct. It was apprised by GM Magadh OCP that the excavation or Non forest activities at Masilaung and Saradhu sites were started in 2018-19 and 2019-20 respectively.

Further, it has been observed that 26.07 ha and 8.47 ha area of GMJJ land were excavated at Masilaung and Saradhu sites respectively (over a period of about 1.5 years).

Out of this 34.54 ha GMJJ land, 27.21 ha was broken/utilized up to 19.11.2016, 5.59 ha was broken/utilized between 2016 to 07.05.2019 and the rest of the 1.74 ha land was broken/utilized after 07.05.2019. The details of broken and fresh land are listed below.




Fig. 1: Aerial view of the violation area (Google Earth Imagery, dated: 26.01.2023)




Fig. 2: Aerial view of the violation area (Google Earth Imagery, dated: 19.11.2016)




Fig. 4: Aerial view of the violation area (Google Earth Imagery, dated: 26.01.2023)

Masilaung site will be reused for further excavate the remains bottom level coal seam which is approximately 17 meters thick. On the other hand, the Saradhu sites is decoaled completely and this area will be used for backfill. The backfill process has already been started.

A small area of about 0.68 ha has been identified beside the lease boundary which is the continuous part of the coal dump, marked as 'DOL' on Fig 1 and 6.

Further, the user agency apprised that consolidated Wildlife Management Plan and Integrated Watershed Development plan for the entire project area (earlier diverted and present proposed) has been prepared and submitted to SFD for required approval.

Since a part of lease is already approved and mining operation already started in non-forest area as well as diverted area, therefore commencement of mining activities and avid continuation of the same has led to FC violation over around 36 Ha of GMJJ forest land.

Observations on the proposed CA areas:

The Compensatory Afforestation (CA) against the above proposals is proposed around 392.71 ha. on Degraded Forest Land (DFL) in Chatra, district. The CA land is comprised in 7 discrete patches located in various forest blocks of different Mauzas (Villages).

1. Encroachment was observed in Kichto, Bargaon, Ulatu 2 and Ulatu 1 (foothill area of Tandwa hill forest) CA lands during field visit. The land identified was

mostly barren land suitable for plantation except some small patches of vegetation and ploughing fields.

- **2.** The identified Laranga, Chor and Jangi CA lands are mostly barren land suitable for plantation except some small patches of ploughing fields in Laranga.
- **3.** The demarcated CA land of Bargaon is not technically and logically acceptable for CA plantations.

Therefore, it is necessary to take action to evict encroachments. The DFO assured the imminent eviction and emphasized that the forest areas with encroachments are deliberately identified and chosen for CA proposals as SFD finds it as an opportunity to permanently remove the encroachment by taking the encroached land under plantations thereby securing them for next 10-12 years. A few photographs of the CA land taken during the field inspections are below:



It is evident from the above that the production discontinued from Masilong Patch as Tenancy land in possession was exhausted. As soon as it was noticed that Mine working is encroaching GM JJ Land, the mine working was stopped.

In Kundi Saradhu Patch Mine working was done in diverted GM JJ Land (96.72 Ha) along with the association of Tenancy land which was possessed by providing the employment under R&R benefit to the concerned tenants.

Mine working was discontinued during April-20 to Oct-20 due to non-availability of possessed tenancy land and again the Mine was stopped in June-21, Dec-22 and from May-23 to till date due to scarcity of possessed land.

Further GM JJ Plot Nos 590 & 706 of Saradhu village were partially diverted (in 96.72 Ha), in which the un-diverted portion was un-intentionally encroached due to measurement error.
