मुझे आपका ध्यान उपर्युक्त प्रस्ताव की और दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए **0.007728** हेक्टेयर वन भूमि की मांग की गई है |

2. This is a case of approach access to residential colony. As per the provisions of sub-section (2) of section 1A of the Van (Sanrakshan Evam Samvardhan)Adhiniyam, 1980 and para 4.1 of the Consolidated guidelines and clarifications Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and Van (Sanrakshan Evam Samvardhan) Rules, 2023, upto 0.1 ha of forest land providing connectivity to the road/railside amenities are exempted from prior approval of the Central Govt and covered under General Approval.

In view of the above, as the instant proposal is less than 0.1 ha and is for access to approach road for proposed site for residential colony, the State Government is requested to process the instant proposal at their level for grant of approval.
