- 1. Government of Odisha vide its letter dated 29<sup>th</sup> January 2014 submitted a proposal to obtain prior approval of Central Government in accordance with section-2 of the Forest (Conservation) Act, 1980 for diversion of 91.929 hectares of forest land (including 4.957 hectares safety zone) in Radhikapur (West) Coal Block under Chhendipada Tahasil in Angul Forest Division in Angul District Odisha for Coal Mining by M/s. Radhikapur (West) Coal Mining Pvt. Ltd.
- 2. Details indicated in the proposal submitted by the Government of Odisha are as below:

		The instant proposal involves 86.972ha. of forest land for mining and other allied activities. Since the area proposed for diversion exceeds 10.0 ha. according to para - 2.2 (ii) the guideline to Forest (Conservation) Act, 1980, sample enumeration over 18 sample plots of 1.0 ha. each located in the applied forest land has been carried out. As such in all, 529 no. of trees of girth 30cm and above have been enumerated. By extrapolating the figures over the entire forest land of 86.972ha. , 2556 no. of trees have been enumerated in the forest area besides 18 no. of bamboo clumps. It is further observed that the most of the trees present are of pole size. In view of this, the crown density of the forest land in the applied area is assessed to be 0.

- 3. Government of Odisha in their said letter dated 29<sup>th</sup> January 2014 submitted following additional information pertaining to the above proposal:
  - (i) Radhikapur(West) Coal Block in Talcher Coal field of Angul District, Odisha has been allotted by Ministry of Coal, Govt. of India in favour of three Project proponents namely (i) M/s Rungta Mines Ltd. (ii) M/s OCL India Ltd. and (iii) M/s Ocean Ispat Pvt. Ltd. vide their letter No. 13016/2005-CA-1, dt. 25.4.2006 as per Option III for extraction of an amount of 119MT,40MT and 48MT respectively for the purpose of their captive use in their Steel, Cement and Captive Power Plants respectively in Odisha. Subsequently as per order of Hon'ble High Court of Odisha dt. 14.9.2009 in WP(C) 12416/2006, the Ministry of Coal, and Government of India vide their letter No. 13016/77/2006-CA-1, dt. 21.12.2009 modified the allocation of this coal block as per Option I. As per condition stipulated in the GoI, Ministry of Coal modification letter dt. 21.12.2009, the three project proponents have constituted a Joint Venture(JV) Company in the name of M/s Radhikapur (West) Coal Mining Pvt. Ltd to develop this Coal Block. This has been registered as a Company under Companies Act, 1956 on 29.3.2010. The copy of certificate of incorporation is enclosed. The Memorandum of Association and Article of Association of M/s Radhikapur(West) Coal Mining Pvt. Ltd are also enclosed.
  - (ii) Radhikapur (West) Coal Block is situated in the western most end of Talcher Coal field in Chhendipada Tehasil of Angul District. It is delineated within latitude of 20° 57′ 28″ 20° 59′ 42″ North and Longitude of 84° 51′ 00″ 84° 54′ 47″ East and forms part of Survey of India Topo Sheet No.73-D/13.
  - (iii) The Radhikapur (West) coal block area is having an area of 10.48 Sq.Km or 1048ha. spread over 8 villages of in Barapada, Kusakila, Naupada, Kusakila Jungle Bar, Jhintipal, Putagadia, Balipata and Kosala in ChhendipadaTehasil of Angul District. The village wise abstract of land required for the project is enclosed. Detailed land schedule of the project area including village wise forest land in Chhendipada tehsil is appended to the DP in a separate volume. IPICOL, Odisha has appraised the requirement of land for this coal mining project and reported accordingly to IDCO. The proposed coal block of 1048ha.ha. is comprised of 730.0302ha. of Private land, 226.0408ha. of Government non-forest land and 91.929ha. of forests kisam land. The forest kisam land of 91.929ha. includes 84.088ha. of Revenue forest, 7.4848ha. of forest land as per sabik record and 0.3562ha. of DLC forest land. The 91.929ha. of forest kisam land include 86.972ha. For mining and other allied activities and 4.957ha. for maintenance of safety zone. The Divisional Forest Officer, Angul in

Part-II of the application form has indicated that forest area proposed for diversion for the project is barest minimum and unavoidable.

- (iv) The Joint Venture Company has applied for mining lease in the allocated Radhikapur(West)coal block for a period of 30 years in Form 'D' to Government of Odisha through Deputy Collector, Mining, Angul on 08.10.2010 for total lease area of 1048 ha including the forest land of 91.929 ha. scattered over the lease hold area. The maximum extent of the block along strike direction (East-West) is 4.8 km that along dip direction is 3.5 km.
- (v) The Central Ground Water Authority, Ministry of Water Resources, Government of India, have issued no objection for drawing of ground water for this coal project vide their letter No. 3143 dt. 1.3.2012. The Ministry of Coal, Government of India vide their letter No. 13016/77/2006.CA-I (Part) dt. 23.6.2011 have approved the Mining Plan for this coal mining project under Section 5(2)(b) of MMDR Act, 1957(page 29/DP). There is an estimated 312.036 Million tonnes of gross geological reserve of coal in this coal block that includes 288.440 in proved category and 23.596MT in indicated category. Life of the Mines in Underground working is 41 years and Open cast workings for 25 years and overall life of mines is 49 years. The underground operations will operate underneath the opencast operations and no new area will be broken/ affected.
- (vi) The proposed lease area does not fall within any National park/Wildlife sanctuary/Biosphere Reserve/Elephant Corridor/Tiger Reserve. No archaeological monument or protected defence establishment is located inside the applied area. No rare, endangered and unique species of flora and fauna are found in the area. The applied area is about 4.5KM from Durgapur Reserved Forests. The total cost of the project is Rs.600.00 Crores. This project will generate direct employment opportunity for 1702 persons directly and nearly twice no. of persons of locality will be benefited indirectly in course of execution of the project.
- (vii) The project involves 1682 no. of Project displaced families and 384 no. of families of project affected families. R&R Plan prepared concerning this project is enclosed.
- (viii) The proposed coal block of 1048ha.ha. is comprised of 730.0302ha. of Private land, 226.0408ha. of Government non-forest land and 91.929ha. of forests kisam land. The forest kisam land of 91.929ha. includes 84.088ha. of Revenue forest, 7.4848ha. of forest land as per sabik record and 0.3562ha. of DLC forest land. The 91.929ha.

(ix) Though the area does not form part of any National Park/Wildlife Sanctuary/Elephant Corridor, due care is to be taken for conservation of Wildlife available in the area. For this purpose, the User Agency is required to pay @ Rs.43,000/- per hectare of leasehold area as per revised norm towards their contribution for implementing Wildlife Management Plan in the applied area if the said area is rich in wildlife. Besides this, the site specific conservation plan for this project is to be implemented in the leasehold as well as surrounding area at project cost. The user agency has also furnished an undertaking to bear the cost for implementing the Wildlife Management Plan.

- (x) The instant proposal involves 86.972ha. of forest land for mining and other allied activities. Since the area proposed for diversion exceeds 10.0 ha. according to para -2.2 (ii) the guideline to Forest (Conservation) Act, 1980, sample enumeration over 18 sample plots of 1.0 ha. each located in the applied forest land has been carried out. As such in all, 529 no. of trees of girth 30cm and above have been enumerated. By extrapolating the figures over the entire forest land of 86.972ha. , 2556 no. of trees have been enumerated in the forest area besides 18 no. of bamboo clumps. It is further observed that the most of the trees present are of pole size. In view of this, the crown density of the forest land in the applied area is assessed to be 0.2.
- (xi) The total benefit of this proposal comes to Rs.111.037 crores. The loss on forests including environmental loss, N.P.V cost and other mandatory payments comes to Rs.15.77 crores. Hence, the cost benefit ratio comes to 1:7.04.
- (xii) An area of 40.908 ha. comprising of 4.957 ha. forest land and 35.951 ha. Non-forest land has been earmarked to be maintained as Safety Zone within the leasehold area. The Safety Zone area will be maintained as Green Belt. The User Agency has furnished an undertaking to bear the cost of maintenance of Safety Zone and cost of forestation over 1.5 times Safety Zone area in degraded forest land elsewhere.
- (xiii) Government of India, MoEF vide their letter No. J-11015/30/2011-IA.II (M) dt. 30.5.2011 have prescribed Terms and References for according environmental clearance for this mining project. Public hearing for this project was conducted on 30.11.2011. A copy of its minutes is enclosed with the proposal. The State Pollution Control Board, Odisha has issued their consent to establish in favour of this project vide their O.M. No.388 dt. 9.1.2013 for a period of five years. The project will be implemented subject to obtaining of environmental clearance from MoEF, Government and Consent to Operate from State Pollution Control Board, Odisha.
- (xiv) The phased reclamation plan and afforestation scheme has been furnished along with the proposal. As indicated in the Plan, the surface is to be stabilized by afforestation in a phased manner. In the first two years, total waste generated will be dumped on external OB dump site located on the non-mining area. From 3<sup>rd</sup> year onward, backfilling will commence and part of OB will be backfilled and

remaining shall be dumped in external dump. After 10<sup>th</sup> year, total OB generated will be backfilled. The user agency has furnished an undertaking for taking up phased reclamation activities.

- (xv) The project involves 1682 no. of Project displaced families and 384 no. of families of project affected families. R&R Plan prepared concerning this project is enclosed. The R&R Plan is required to be implemented with due approval of the RPDAC/State Government before commencement of project activities on final forest clearance.
- (xvi) The Ministry of Coal, Government of India vide their letter No. 13016/77/2006.CA-I (Part) dt. 23.6.2011 have approved the Mining Plan for this coal mining project under Section 5(2) (b) of MMDR Act, 1957. There is an estimated 312.036 Million tons of gross geological reserve of coal in this coal block that includes 288.440 in proved category and 23.596MT in indicated category. Life of the Mines in Underground working is 41 years and Open cast workings for 25 years and overall life of mines is 49 years. The underground operations will operate underneath the opencast operations and no new area will be broken/ affected.
- (xvii) As indicated in Part-II of the application form by the Divisional Forest Officer, Angul, his site inspection report, Site inspection report of RCCF, Angul, no violation of Forests Conservation Act, 1980 has been committed so far in this project.
- (xviii) The user agency is required to deposit the cost of NPV for entire forest land of 91.929ha. in this project. The User Agency has also furnished an undertaking to pay the NPV at revised rate.
- (xix) As per Govt. of India, MoEF circular vide F.No. 11-9/1998-FC(Pt.) dt. 3.8.2009/5.2.2013/5.7.2013 in the matter of ensuring compliance to the provisions of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 while processing a forest diversion proposal, the Collector, Angul has furnished the required compliance in the matter as indicated below.
- (xx) In the instant forest diversion proposal that involves 91.929ha. of forest land, the Collector, Angul has furnished the following certificates/documents pertaining to the forest land proposed for diversion for coal mining in Radhikapur(West) Coal block in Angul district:
  - (a) Certificates duly signed by the Collector, Angul for 91.4075ha. and 0.5217ha

- (b) Resolution passed by the Palli sabhas of Barpada village in the meeting held on 30.9.2011, Jhintipal village held on 26.8.2011, Putagadia village held on 14.8.2011, Naupada village held on 16.12.2011, Kusakila village held on 11.12. 2011, Balipata held on 30.4.2013 duly signed by the Members present in regional language
- (c) English version of the resolution of Palli sabha submitted by the Collector, Angul.
- (xxi) Ministry of Environment and Forests, Government of India in their letter F. No. 11-9/98 dated 8.7.2011 have issued guidelines that all applications seeking prior approval of the Central Government under Forest (Conservation) Act, 1980 for diversion of forest land for non-forest purpose must be accompanied with Georeferenced boundary in shape file pertaining to forest land proposed for diversion. These documents/Maps are required to ensure accurate delineation of the forest area to be diverted. The user agency in compliance to this order, has submitted the required digital map duly authenticated by ORSAC and Divisional Forest officer, Angul Forest Division which is enclosed along with the shape file. The soft copy in CD-Form is also appended for reference
- 4. The State Government has finally recommended that in view of the above position, Government of India, Ministry of Environment, may kindly examine this proposal for diversion of 91.929 ha forest land (including 4.957 ha. Safety Zone) in Radhikapur (West) Coal Block under Chhendipada Tahasil in Angul Forest Division of Angul District, Odisha for coal mining by M/s Radhikapur(West) Coal Mining Pvt. Ltd. and convey their approval under Section-2 of Forest (Conservation) Act,1980 in favour of the User Agency to this department subject to the following stipulation:
  - (i) The User Agency shall pay the proportionate cost of implementation of Regional Wildlife Management Plan at revised cost when fixed in case the area is considered rich in wildlife.
  - (ii) The forest land earmarked in the safety zone is to be maintained strictly and in no circumstances, it shall be used for mining and other allied activities.
  - (iii) The user agency shall pay towards the cost of site specific conservation plan approved by the CWLW, Odisha for its implementation in leasehold as well as surrounding area.
  - (iv) The user agency shall undertake demarcation of the lease area on the ground posting four feet high cement concrete pillars embedded two feet inside the soil with serial number, forward and backward bearings, and distance from pillar to pillar. The user agency shall also submit the map of lease area showing different kinds of forest land

using DGPS survey datas and latitude and longitude of each pillar to the Divisional Forest Officer, Angul for his reference before commencement of work on final forest clearance.

- (v) Felling of trees in the applied area shall be taken up in phased manner strictly as per requirement prescribed in the approved Mining with prior permission of the Divisional Forest Officer, Angul.
- (vi) User agency shall pay the royalty of numbers of enumerated trees before commencement of work on final forest clearance.
- (vii) The user agency shall obtain environmental clearance of MoEF and Consent to Operate from the SPCB, Odisha for the project.
- (viii) Duly approved R&R Plan shall be executed at project cost before the Mines is operated on having final forest clearance.
- (ix) The user agency shall provide the DGPS/ETS map of Coal Block area as per provisions of the Steel & Mines Department Officer order No. 4132/SM dt. 8.5.2013.
- 8. The proposal is placed before the Forest Advisory Committee (FAC) for their examination and appropriate recommendations.
