Proposal for issuance of permission under FC Act, 1980 towards grant/re-grant of Ningru and Ningru Extension Petroleum Mining Lease covering 615.668 sq. km. (61566.8 ha) falling under Sub: Lohit and Changlang Districts of Arunachal Pradesh in favour of M/s Oil India Limited (OIL).

Sir,

Please refer to the State Government of Arunachal Pradesh's letter no. FOR.14-8/Cons/2003/Pt/358-59 dated 02<sup>nd</sup> March, 2015 for issuance of permission under FC Act, 1980 towards grant/re-grant of Ningru and Ningru Extension Petroleum Mining Lease (PML) covering 615.668 sq. km. falling under Lohit and Changlang Districts of Arunachal Pradesh in favour of M/s Oil India Limited.

The matter has been examined in the Ministry in detail. It has been found that there is a variation in the proposal originally submitted by the State Government on 22.09.2006 and the current proposal. The original proposal for renewal of mining lease was for diversion of 540.668 sq. km. of forest land at Ningru area of Lohit and Changlang Districts of Arunachal Pradesh. No proposal for extension of PML in Ningru Extension area was received by this Ministry in the past. Therefore, it is necessary that the State Government clarifies whether the user agency intends to execute the two separate mining leases for 540.668 sq. km. in Ningru area and 615.668 sq. km. in Ningru & Ningru Extension area or they are intending to execute a single mining lease for both the areas. In case user agency intends to execute the separate mining lease then the proposal for prior approval of Govt. of India for assigning of the forest land by way of lease for the purpose of executing PML under Section (iii) shall be submitted for the two areas separately and in case they want to have a combined mining lease for both the areas, then a combined proposal may be submitted under Section 2(iii) in accordance with the Ministry's guidelines dated 24.06.2015.

Further, it is clarified that the proposal forwarded by the State Government on 2<sup>nd</sup> March, 2015 is found to be incomplete. Only Part-I of the form has been submitted. As per the guidelines, the complete proposal is required to be submitted by the State Government. Therefore, you are requested to take action accordingly.
