- **3.** The State Government of Odisha has furnished the following additional information on the project as bellow:
 - A mining lease was granted over 333.063 ha (19.732 ha. of Khesra Forest +311.109 ha. of Govt. non-forest + 2.222 ha. of tenanted land) for Iron & Manganese ore in favour of Sri S.N. Mohanty of Barbil, Dist. Keonjhar (now deceased) for period of 20 years and accordingly the lease deed was executed on 20.1.1987. Which was valid till 19.1.2007. Later, another lease was granted for mining of bauxite ore in the above mentioned mining lease area for which supplementary lease deed was executed on 11.12.1989. The lease period of bauxite ore was to be co-terminus with the original lease deed executed earlier for iron and manganese ore . After the demise of the original lessee i.e.sri S.N. Mohanty, Govt of Odisha in the Dept. of Steel & mines accorded permission vide their Letter dated 11.3.1999 in favour of Sri Prabodh Mohanty, Legal heir of Late S.N. Mohanty to continue mining operation and to inherit the pending PL/ML applications of his deceased father. - In the meanwhile, the lessee applied for 1st renewal of mining lease over an reduced iii. area of 188.523 ha only on 06.12.2005, which is entire forest land, out of original MI are over 333.063 ha. under Rule-24A(1) of MCR, 1960 which is a part of the originally granted/executed area and thereby surrendering of balance 144.540 ha of the originally granted ML area. The final Mine Closure Plan (FMCP over the proposed surrendered are of 144.540 ha (non-mineralized zone) has been approved by IBM, Bhubaneswar vide their Letter No. FMCP/OTF.MECH/09-ORI/BHU/2010-11 Dt, 12.01.2011(page 84-84A/DP) and a certificate to this effect has been issued by IBM, Regional Controller of Mines, Bhubaneswar vide their letterNo. T/FMCP/C/1/BHU-2011 dtd. 11.01.2012(page 84B/DP). Accordingly, Director of Mines, Odisha vide has letter No. MIV (B) -125/05-1221/DM.dtd. 07.02.2013 (page - 82-83/DP) proposed for disposal of 1st RML application of the lessee by Government of Odisha in Steel and Mines department along with approval for taking over possession of the area over 144.540 ha surrendered by the lessee. Ltd, a Company registered under the Companies Act, 1956 ha signed an M.O.U with the State Government on 22.12.2006 to set up an Integrated Steel Plant of 0.25 MTPA capacity and Captive Power Plant of 16MW at barahamusa in Bonai area os Sundargarh district. This project will generate employment for 457 persons daily during the lease period. Further this project does not involve any displacement of human habitation.

iv. As indicated by PCCF, Odisha, the comparison between Sabik and Hal settlement status of the land in this mining lease does not arise as the Hal Settlement in Sundargarh district has taken place prior to 1980 i.e in the year 1975.

6. Flora & Fauna

i. As reported by PCCF, Odisha, tree species commonly noticed in this area are Shorea robusta, Bauhinia vahlii, arhdina cordifolia, Terminzalia tomentosa, syzygium cuminin, scelichera oleosa, Anogeissus latifoloa, diopsyros melanxylon, Buchanania lanzan, lgerstreoemia parviflora etc. Shorea robusta is the pre-dominant species. Similarly wild animals such as Oryctolaugs cunniculus (Hare), Sus scrofa cristatus (wold boar), Fellies chaus affinis(Jungle cat), Canis aureus (Jackal), Snakes and different type of birds are

noticed in the area. No rare or endangered species of flora or fauna is noticed in this area.

7. Wildlife Management

i. The user agency has already deposited an amount of Rs. 81,06,489/- in favour of Adhoc CAMPA towards the proportionate cost of Regional Wildlife Management Plan as per the revised norm @ Rs. 43,000/- per ha over the lease hold area of 188.523 ha in two phases i.e. for Rs. 37,70,460/- vide DD No. 023800 dated 28.05.2009 and Rs. 43,36,029/- through RTGS dated on 4.11.2013 in Union bank of india, Sundarnagar Branch , New Delhi vide UTR No. HDFCH1330854747. Similarly, the Specific Wildlife Conservation Plan for this project prepared by the user agency has been approved by the PCCF (Wildlife) & CWLW, Odisha with a total financial outlay of Rs. 70,00,000/-. The said amount has also been deposited by the user agency in favour of Ad-hoc CAMPA vide DD No. 024381 dated 09.07.2009.

8. Tree enumeration

i. The forest land applied for diversion is 11.006 ha which involoves 9.778 ha safety zone area and 1.228 ha to be used for public purpose as road by the villagers of Jaldihi. As reported by the DFO, Bonai in his site inspection report, 1234 no. of trees have been enumerated over 9.778 ha. of forest land earmarked to be maintained as safety zone, which are not to be felled. Further it has been reported that there is no forest growth over 1.228 ha which is required to be diverted for non-forest purpose of road. Detailed tree enumeration report over safety zone area and that over 1.228ha. of forest land for road purpose. Density of vegetation over the safety zone area is reported to be 0.3.

9. Compensatory Afforestation

i. The instant forest diversion proposal of 11.006 ha of forest land includes 9.778 ha of safety zone area and 1.228 ha for public purpose as road. No compensatory afforestation is required for forest land to be diverted under safety zone. However, compensatory afforestation is required to be taken up against the diversion of 1.228 ha. required to be used as road by the villagers of Jaldihi. Accordingly, equivalent non-forest land over 1.228 ha. has been identified/allotted in village Bhurung (Tehsil Gurundia) under Tamra Range ofBonai Forest Division by the Collector, Sundargarh as per land schedule given below for the purpose of raising compensatory afforestation.

ii. The identified non-forest land is certified to be free from encroachment and encumbrance and non-encroachment and non-encumbrance certificate issued by the Tahasildar, Gurunida, has been furnished to the CA Scheme as Annexure-V. The suitability certificate furnished by the DFO, Bonai is enclosed vide Annexure-VI of the CA Scheme. The area identified for the CA is not included in the DLC report of Sundargarh district. The DFO, Bonai has prepared a site specific CA scheme in ANR mode for taking up plantation of 200 Plants per ha. Considering the existing vegetation with a total financial forecast of Rs. 11,53,500/- as per current wage rate of Rs. 200/-per Manday and with 10 years maintenance provision. The Addl. PCCF (Forest Diversion & Nodal Officer) FC Act has accorded technical approval for this CA scheme. Copy of the CA scheme is placed. Map of the CA land shown in the cadastral map of village Bhrung duly signed by all concerned and map showing treatment of CA area are furnished at page 140 A-b of the DP. The user agency has furnished and undertaking to bear the cost of the Compensatory Afforestation.

10. Safety Zone

i. An area of 9.778 ha (Revenue Forest land 0.682 ha + PRF 4.65 ha + DLC Forest land 4.446 ha) has been earmarked to be maintained as safety zone in this mining lease. In compliance to the conditions imposed in the previous diversion of 177.517 ha., the user agency. The user agency has deposited an amount of Rs. 11,74,300/- in favour of Adhoc CAMPA towards cost of maintenance of safety zone area. Further a scheme for afforestation on 1.5 times safety zone ara i.e. over 14.667 ha of degraded forest land identified in Dharnaidhuarpali RF in Bonai Forest Division has been approved and an amount of Rs. 14,96,600/- towards approved cost of the said scheme has also been deposited in Ad-hoc CAMPA. As reported by PCCF, Odisha the above schemes are now under execution. 1st year plantation was taken up during 2010-11, and 3rd year maintenance has been complted during 2013-14.

11. Cost Benefit Analysis

i. The details of C.B analysis has been drawn for this mining project. It states that total loss account of this project comes to Rs. 924 lakhs and totatl benefit owing to this project is in the order of Rs. 9900 lakhs. Thus the cost : benefit ratio for this project is assessed at 1 :11 . Details of C:B analysis.

12. Environmental Clearance

The lessee has obtained Environment Clearance from MoEF, GoI Vide Letter No. J-11015/417/2006-IA. II (M) dt. 28.1.2008 for production of 7,00,000 tonnes of iron ore, 50,000 tonnes of bauxite ore by open cast semi-mechanised method involving MI area of 188.523 ha. (Annexure-XIX, Page 99-106/DP). State Pollution Control Board vide their order dt. 14.3.2011 has granted Consent to Operate in favour of this project which is valid till 31.3.2016.

13. Phased Reclamation Plan

i. The Phased Reclamation Plan has been furnished. This plan includes reclamation of exhausted pits by back-filling with mine waste materials, taking up of block plantation over the stabilized dumps as well as vacant areas. The user agency has furnished an undertaking to execute the scheme.

14. Mining Plan

i. The Mining Plan with Progressive Mine Closure Plan for this mine has been approved by the Indian bureau of Mines vide their Letter No. 314 (3) /2010-MCCM (CZ) / Ms-40 dt. 6.4.2011 with validity up to 31.3.2016. A copy of the approved Mining Scheme with progressive Mine closure Plan is submitted in a separate volume.

15. Violation

i. No violation of the Forest (Conservation) Act, 1980 in this lease has been reported in the site inspection report of DFO, Bonai Forest Division.

16. Resettlement & Rehabilitation Plan

i. The project does not involve displacement of any human habitation. Hence, R&R plan is not required.

17. Others

i. The original mining lease area was of 333.063 ha. The said MI area was comprised of 14.0166ha. of Proposed Reserved Forest (PRF), 170.141 ha. of DLC (District Level Committee) forest land, 19.733 ha. of revenue forest land and remaining 3.023ha. nonforest land. As usch total foreset ksiam land in this mining lease comes to 330.040 ha. During 1st RML period, the lessee had proposed to surrender 144.5403 ah including 141.5174 ha forest land. The lessee had earlier deposited an amount of Rs. 13,76,21,790/- towards NPV for entire 188.523 ha. of forest land applied for 1st RML which also included forest land of safety zone @ Rs. 7.30 lakhs per hectare. However, as per demand of DFO, Bonai, the lessee did not deposit an amount of Rs. 10,33,07,410/- towards NPV demanded for the remaining 141.517 ha. of forest land applied for surrender (But not yet finally accepted by State Government) and instead challenged the demand notice of the DFO, Boani Forest Division in this context by filing Writ Petition No. 24646 of 2013 and Misc. case nO. 224001 of 2013 before the Hon'ble High Court, Otissa. In compliance to order of Hon'ble High Court dt. 14.2.2014 in this Writ Case, the lessee deposited an amount of Rs. 5,16,53,705/- (50% of total demanded amount of Rs. 10,33,07,410/-) through RTGS mode on 20.2.2014 in favour of Adhoc-CAMPA in Account No. 344902010105428 in Union bank of India, Sundernagar, New Delhi vide UTR No. UTIBH14051094545. Thus so far, the lessee has deposited an amount of Rs. 18,92,75,495/- towards NPV for this mine. However, the Hon'ble High Court, in their subsequent order dt. 17.9.2014 in this Writ case, has set aside the demand notice and directed to refund the amount deposited by the petitioner vide their order dt. 14.2.2014. On the advice of Law department, State Government has also moved the Adhoc-CAMPA to refund the amount of Rs. 5, 16, 53, 705/- through RTGS mode on 20.2.2014 in favour of Ad-hoc-CAMPA, as referred to above. Response of Ad-hoc-CAMPA is not yet received in this context. The user

agency, ahs however, furnished an undertaking for deposit of NPV, as would be determined.

ii. Site inspection report of the DFO, Bonai Forest Division. Basic information of Bonai division, Sundargarh district and State Government of Odisha.

18. Geo-referenced Map (DGPS)

i. In compliance to the MoEF guidelines No. F.NO- 11-9/98-FC dated 08.07.2011 to ensure accurate delineation of the forest area proposed to be diverted for non-forestry purposes under Section-2 of Forest (Conservation) Act, 1980, the DGPS map of the mining lease area showing the forest patch duly verified by ORSAC and authenticated by the Divisional Forest officer, Boani Division, is enclosed as Plate no – 11 to the DP along with the soft copy in CD form.

19. Certificate under Forest Right Act, 2006

- i. In compliance to the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, the Collector, Sundargarh has issued the required certificate for 188.523ha. of forest land applied for renewal which also includes 11.006 ha of forest land proposed for diversion of forest land proposed for diversion for safety zone/public purpose now. The copy of the FRA certificate along with Gram Sabha resolutions for village Kalamong(dt. 9.7.2014 for 72.687 ha.), Jaldihi (dt. 9.7.2014 for 42.096ha.), Sidimba (dated 9.7.2014 for 37.714ha.) and Tantigram (dated 9.7.2014 for 36.026ha.) Odia language and their English translation are submitted.
- **20.** PCCF, Odisha has recommended this proposal, All the prescribed proforma have been filled up and relevant maps/undertakings have been furnished.
- 21. The State Government has finally recommended that in view of the above Government of India, MoEF & CC, may kindly examine the proposal for diversion of the balance forest land of 11.006 ha (Safety Zone 9.778 ha and area for public purpose -1.008 ha) excluding 177.517 ha. of already diverted forest land out of total forest land of 188.523ha. within the applied mining lease area of 188.523ha. for Iron, Manganese and Bauxite Mining in villages Kalmang, Jaldihi, Sidimba and Tantigram (KJST) under Koira Tehsil of Sundargarh District by Sri Prabodh Mohanty, Legal heir of Late S.N. Mohanty during the mining lease period to be granted / executed under amended provision of MMDR Act, 2015 and convey their approval in favour of the project to this department under Section 2 of the Forest Conservation Act, 1980 subject to the following conditions:
 - i. Forest area earmarked as safety zone in the ML area as well as for public purpose (road) shall be demarcated by posting of pillars of appropriate length, protected, fenced, afforested at project cost. In no circumstances, the area earmarked as safety zone /public purpose (road), shall be utilized for any other purpose.
 - ii. User Agency has to execute Phased Reclamation Plan at their cost.

22. It is therefore, proposed that the proposal may be placed before the Forest Advisory Committee (FAC) during its next meeting for its consideration and appropriate recommendations.
