I, am directed to invite your attention to the reference 3<sup>rd</sup> cited, in which the Government of India, Ministry of Environment and Forestry, have accorded approval in-principle (Stage-I) U/s 2 of Forest (C) Act, 1980, for diversion of forest land to an extent of **4.336 ha** in erstwhile Kothagudem forest division and presently Yellandu forest division under Bhadadri-Kothagudem, for laying of Pipeline in **Segment-25/4 (Regalla Gutta)**, for providing safe drinking water under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Khammam, subject to fulfillment of certain conditions as stipulated therein.

2. The Principal Chief Conservator of Forests (HoFF), Telangana State, in his letter 5<sup>th</sup> cited, has submitted condition wise compliance report on the conditions stipulated in in-principle (Stage-I) approval. The details of which are as follows:-
