
As per the In-principle approval cum demand letter No. 7-5/3-FD/565/63 dated 30/11/2017 regarding the above mentioned proposal it has been informed to deposit the amount of **Rs.8,70,150** towards the Compensatory Afforestation and Net Present Value (NPV) and also informed that the formal order will be issued after the compliance of the conditions mentioned in above mentioned letter. The same has been compiled for your kind consideration and the compliances are as following.

i.	The legal status of the forest land shall remain unchanged i.e shall remain Reserve Forest	Agreed
ii.	No felling of tree shall be involved in the implementation of the proposal.	The project involves no felling of tree.
iii.	The maximum size of the trench shall not be more than 2.00 meter depth and 1.00 meter width.	Agreed
iv.	Compensatory afforestation shall be taken up the by the Forest department at the cost of the user agency and the same shall be maintained for 10 years. Only indigenous/nature forest tree species shall be used for such plantations. Trees, if planted on the diverted area, will not be felled without the permission of the State Forest Department.	Agreed. The payment towards CA and NPV has been transferred towards the details mentioned in the challan generated from the website.
v.	The user agency shall pay the Net Present Value (NPV) of the diverted forest land as stipulated by the Ministry of the Environment , Forests and climate change from time to time.	Agreed.

vi.	Additional amount of the Net present value of the diverted forest land if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert committee shall be charged by the State Government from the user agency . The User agency shall furnish an undertaking to this effect.	Agreed. The undertaking for the same is submitted herewith.
vii.	The user agency shall seek permission from Forest Department, Dadra & Nagar Haveli for carrying out maintenance. The User agency shall be responsible for any loss to the flora/fauna in the surroundings and therefore, shall take all possible measures to conserve the same.	Agreed. The best possible and strict measures shall be taken to conserve the flora/fauna during construction.
viii.	All statutory provisions under various acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.	Agreed.
ix.	All the fund received from the User Agency under the project shall be transferred to the Ad-hoc Compensatory Afforestation Fund Management & Planning Agency (CAMPA) in Saving Bank A/c No. SB01025204 (CAF D&NH) in Corporation Bank , Lodhi Complex , New Delhi – 110003.	The payment has been transferred towards the details mentioned in the challan generated from the website.
x.	The User agency has to pay Rs.3,87,338/- towards Net Present value of land and Rs. 4,82,812/- towards Compensatory Afforestation including maintenance for 10 years.	The payment has been transferred towards the details mentioned in the challan generated from the website.
xi.	The forest land shall not be used for any purpose other than that specified in the proposal.	Agreed.
