I, am directed to invite your attention to the reference 5<sup>th</sup> cited, in which the Government of India, Ministry of Environment and Forestry, have accorded approval in-principle (Stage-I) U/s 2 of Forest (C) Act, 1980, for diversion of **6.926 ha** of forest land in Erstwhile WLM Division, Paloncha of Khammam District and presently falling under the jurisdiction of Forest Divisional Officer, WLM Division, Kinnerasani of Bhadradi District for laying of Pipeline and Construction of structures for **Segment-25/7 (Banjara)** under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Khammam, subject to fulfillment of certain conditions as stipulated therein.

2. I am further to inform that the Principal Chief Conservator of Forests (HoFF), Telangana State, in his letter 7<sup>th</sup> cited, has submitted condition wise compliance report on the conditions stipulated in in-principle (Stage-I) approval. The details of which are as follows:-

The Nodal Officer must report compliance within a period of 6 Months from the date of grant of final approval and send a copy of the original notification declaring the non forest land under section 4 or Section 29 of the Indian Forest Act 1927 or under the relevant section of the local Forest Act as the case may be, to this office for information and record.
