

I, am directed to invite your attention to the reference 5th cited, in which the Government of India, Ministry of Environment and Forestry, have accorded approval in-principle (Stage-I) U/s 2 of Forest (C) Act, 1980, for diversion of **6.926 ha** of forest land in Erstwhile WLM Division, Paloncha of Khammam District and presently falling under the jurisdiction of Forest Divisional Officer, WLM Division, Kinnerasani of Bhadradri District for laying of Pipeline and Construction of structures for **Segment-25/7 (Banjara)** under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Khammam, subject to fulfillment of certain conditions as stipulated therein.

2. I am further to inform that the Principal Chief Conservator of Forests (HoFF), Telangana State, in his letter 7th cited, has submitted condition wise compliance report on the conditions stipulated in in-principle (Stage-I) approval. The details of which are as follows:-
