| v. | Additional amount of the NPV of the diverted if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert committee shall be charged by the State Government from the user agency . The User agency shall furnish an undertaking to this effect. | Agreed. The undertaking for the same is submitted herewith. |
| vi. | The User agency shall be responsible for any loss to the flora/fauna in the surroundings and therefore, shall take all possible measures to conserve the same. | Best possible and strict measures shall be taken to conserve the flora/fauna during construction. |
| vii. | The User agency shall submit the FRA certificate in accordance with the provisions of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act , 2006 before issue of Formal approval. | The FRA certificate has been obtained from the District Magistrate/Collector and is attached herewith for your kind perusal please. |

| x. | The forest land shall not be used for any purpose other than that specified in the proposal. | Agreed. |


