The user agency shall furnish an undertaking to this effect.	Complied
7	All the funds received from the user agency under the project shall be transferred /deposited to CAMPA fund only through (https://parivesh.nic.in/)	Complied
8	State Government shall complete settlement of rights, in term of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006, if any on the forest land to be diverted and submit the documentary evidence as prescribed by this Ministry in it's letter No. 11-9/1998-FC dated 3 rd August 2009 read with 05.07.2003, in support thereof.	Will be complied

9	The layout plan of the proposal shall not be changed without prior approval of Central Government.	Agreed
10	No labour camp shall be established on the forest land.	Agreed
11	No additional or new path will be constructed inside the forest area for transportation of construction materials for execution ofm the project work.	Agreed
12	The forest area shall be used for the purpose for which it is granted. The total forest area utilised for the project shall not exceed 0.2 ha.	Agreed
13	The forest land proposed to be diverted shall under no circummstances be transferred to any other agencies, Department or person without prior approval of Government of India.	Agreed
14	The period of diversion under this approval shall be co-terminus wih the period of lease to be granted in favour of the user agency or the project life whichever is less.	Agreed
15	The compliance report shall be uploaded on e-portal (https://paivesh.nic.in/)	Complied
16	Any other condition that the Ministry of Environment Forest and Climate Change may stipulate from time to time in the interest of conversion, protectuion and development of forest and Wildlife.	Will be complied
