I am directed to invite your attention to the reference 3rd cited, wherein, the Government of India, Ministry of Environment & Forests, Chennai have accorded approval in-principal (Stage.I) for diversion of **4.698 ha** of forest land in Adilabad Division for laying of Pipelines and construction of Structures for **Segment-21/2 (Chenchughat)** under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Nirmal, subject to the fulfillment of certain conditions as stipulated therein.

2. The Principal Chief Conservator of Forests (HoFF), T.S., has submitted that the District Forest Officer, Adilabad/ Forest Divisional Officer, Adilabad has obtain compliance of conditions from the User Agency and submitted the condition-wise compliance report together with its enclosures through I/c Conservator of Forests, Adilabad, which is received in this office through vide letter dt.08.04.2019. A copy of vide letter dt.08.04.2019 together with its enclosures **in triplicate** are enclosed herewith.

3. The condition wise compliance report is reproduced as follows:-
