I am directed to invite your attention to the reference 3rd cited, wherein, the Government of India, Ministry of Environment & Forests, Chennai have accorded approval in-principal (Stage.I) for diversion of 4.145 ha of forest land in Adilabad division for laying of Pipe Line and Construction of structures in Segment-21/1 (Mavala) for providing safe drinking water to Adilabad District under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Nirmal, subject to the fulfillment of certain conditions as stipulated therein.

The Principal Chief Conservator of Forests (HoFF), T.S., has submitted 2. that the District Forest Officer, Adilabad has obtain compliance of conditions from the User Agency and submitted the condition-wise compliance report together with its enclosures through I/c Conservator of Forests, Adilabad, which is received in this office through vide letter dt.08.04.2019. A copy of vide letter dt.08.04.2019 together with its enclosures in triplicate are enclosed herewith.

The condition wise compliance report is reproduced as follows:-3.
