Please refer to your letter F.No. 6-GJC032/2019-BHO/172 dated 12.02.2020 on the subject cited above and it is informed that:-

24	The Complete compliance report for all conditions stipulated in this Stage I approval letter shall be uploaded one-portal ( <a href="https://parivesh.nic.in">https://parivesh.nic.in</a> ).	The Compliance report is uploaded on e-portal.
