The Government of India, Ministry of Environment, Forest and Climate Change, Bengaluru vide reference (1) has accorded '*in-principle*' (Stage-I) approval for diversion of 1.645 hectare (revised from 1.7456 hectare) of forest land in SM Block, DM Block & Sy. No. 224 of Bannihatti Village (Section-4 proposed area) in Ballari District for proposed Main Pipe Conveyor Belt Corridor from Nandihalli Railway Yard to JSW plant in favour of M/s JSW Steel Ltd, Vidyanagar, Ballari District under Section 2 of the Forest (Conservation) Act, 1980 subject to certain conditions. Accordingly, the User Agency and field officers were directed by this office vide reference (2) to submit the compliance to the conditions of Stage-I approval.
